तूतुकुडि पत्तन न्यास कर्मचारी (भर्ती, वरिष्ठता तथा पदोन्नति) संशोधन विनियम, 2016

महा पत्तन न्यास अधिनियम, 1963 (1963 का 38) की धारा 28 द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, व.उ. चिदम्बरनार पत्तन के बोर्ड के न्यासीगण, एतद्वारा तूतुकुडि पत्तन न्यास कर्मचारी (भर्ती, वरिष्ठता एवं पदोन्नति) विनियम, 2008 को, और आगे संशोधन करने हेतु, निम्नलिखित विनियम बनाते हैं, अर्थात् :-

1 लघु शीर्ष एवं प्रारंभ :

(i) ये विनियम, तूतुकुडि पत्तन न्यास कर्मचारी (भर्ती, वरिष्ठता एवं पदोन्नति) संशोधन विनियम, 2016 कहे जाएं।

(ii) ये, भारत के राजपत्र में, महा पत्तन न्यास अधिनियम, 1963 की धारा 124 एवं 132 के प्रावधानों के तहत, आवश्यकतानुसार केन्द्र सरकार के अनुमोदन से, प्रकाशन होने की तारीख से प्रभावी होंगे।

2 तूतुकुडि पत्तन न्यास कर्मचारी (भर्ती, वरिष्ठता एवं पदोन्नति) विनियम, 2008 में, खंड (क्यू) के नीचे विनियम 3 के तहत, निम्नलिखित को (आर) के रूप में जोड़ा जाए :-

“(आर) किसी भी ग्रेड के संबंध में, “नियमित सेवा” का तात्पर्य, चयन के उपरान्त और उक्त ग्रेड में नियमित नियुक्ति के लिए निर्धारित प्रक्रिया के अनुसार, नियमों के तहत हुई नियुक्ति के बाद, की गई सेवा की अवधि या अवधियाँ और जिसमें कोई भी अवधि या अवधियाँ शामिल हैं :

- (i) विनियमों की अधिसूचना के समय पर, जो पहले से ही सेवा कर रहे हो, के मामलों में, वरिष्ठता के उद्देश्य के लिए ध्यान में रखा जाएगा।
- (ii) जिस अवधि के दौरान, अधिकारी ने उक्त ग्रेड में पद को संभाला हुआ होगा, पर लेकिन छुट्टी पर रह रहे थे या अन्यथा ऐसे पदों को संभालने के लिए उपलब्ध नहीं थे। ”

#### V.O.CHIDAMBARANAR PORT TRUST

##### **Tuticorin Port Trust Employees (Recruitment, Seniority and Promotion) Amendment Regulations, 2016**

In exercise of the powers conferred by Section 28 of the Major Port Trusts Act, 1963 (38 of 1963), the Board of Trustees of V.O.Chidambaranar Port hereby makes the following Regulations further to amend the Tuticorin Port Trust Employees (Recruitment, Seniority and Promotion) Regulations, 2008, namely:—

#### 1. Short Title and Commencement:

- (i) These Regulations may be called the Tuticorin Port Trust Employees (Recruitment, Seniority and Promotion) Amendment Regulations, 2016;
- (ii) They shall come into force on the date of publication of the approval of the Central Government as required under the provisions of Sections 124 and 132 of the Major Port Trusts Act, 1963, in the Gazette of India.

2. In the Tuticorin Port Trust Employees (Recruitment, Seniority and Promotion) Regulations, 2008, under Regulation 3, below clause (q), the following shall be added as clause (r):

“(r) ‘Regular Service’ in relation to any grade means the period or periods of service in that grade rendered after selection and appointment thereto under the regulations according to the prescribed procedure for regular appointment to that grade and includes any period or periods:

- (i) Taken into account for the purpose of seniority in case of those already in service at the time of notification of regulations;
- (ii) During which an employee would have held a post in that grade but for being on leave or otherwise not being available for holding such posts.”

- iii) Post qualification experience of 3 years in case of PG Degree holders and 5 years experience in case of PG Diploma holders in the relevant field of specialization in a reputed hospital”.

- (2) for the post of Deputy Chief Medical Officer (Specialist), the provisions under Col.No.8 shall be substituted as under:-

“Essential:

- i) MBBS degree from a recognised University.
- ii) A Post Graduate (PG) Medical Degree or PG Medical Diploma in the specified speciality from a recognised University.
- iii) Post qualification experience of 7 years in case of PG Degree holders and 9 years experience in case of PG Diploma holders in the relevant field of specialization in a reputed hospital”.

- (3) for the post of Senior Deputy Chief Medical Officer, the provisions under Col.No.8 shall be substituted as under:-

“Essential:

- i) MBBS degree from a recognised University.
- ii) A Post Graduate (PG) Medical Degree or PG Medical Diploma in the specified speciality from a recognised University.
- iii) Post qualification experience of 10 years in case of PG Degree holders and 12 years experience in case of PG Diploma holders in the relevant field of specialization in a reputed hospital”.

- (4) for the post of Chief Medical Officer, the provisions under Col.No.8 shall be substituted as under:-

“Essential:

- i) MBBS degree from a recognised University.
- ii) A Post Graduate (PG) Medical Degree or PG Medical Diploma in the specified speciality from a recognised University.
- iii) Post qualification experience of 13 years in case of PG Degree holders and 15 years experience in case of PG Diploma holders in the relevant field of specialization in a reputed hospital”.
