# 1. INTRODUCTION

## 1.0 Background

V.O.Chidambaranar Port Authority (VOCPA) is one of the 12 Major Ports in India and the second largest port in Tamil Nadu. Declared as major port in 1974. VOCPA has an all-weather natural harbour and is being developed into a transshipment and cargo-handling hub. To meet its growing capacity needs and strategic vision, VOCPA has proposed to develop various projects that will enhance VOCPA's throughput and competitiveness.

### 1.1 VOCPA's Key Infrastructure Projects

VOCPA has identified the following **priority infrastructure projects** for PPP, EPC & HAM development:

1. **Ship-building yard inside the Port**
2. **Mechanization of Berth 7**
3. **Mechanization of Berth 10**
4. **Strengthening and Mechanization of Berths 3 & 4**
5. **Strengthening and Mechanization of Berths 1, 2, 5 & 6**

### 1.2 Objectives

The primary objective of the consultancy services is to prepare a Detailed Project Report (DPR) for the **five projects** identified above.

Summary of tasks what consultant is expected to perform:

- a. To assess / re-assess the current and future demand for the proposed facility including competition analysis vis-à-vis other trans-shipment facilities in neighbouring areas and countries and divert ability of the traffic.
- b. Review and incorporate the findings of previous studies undertaken. Focus areas for the study include — Demand assessment of Transshipment Traffic, approaches to improve transshipment Traffic, evaluation of amount of investment, optimum vessel fleet required, preliminary social assessment, Environment sustainability plan (if made), **funding and financing arrangements** for construction and operations.
- c. To review the engineering surveys and investigation including topographical / hydrographical survey and geo-technical / geological investigation in order to identify the design and project components — marine structures (including break waters), port and berth layout, dredging and reclamation, navigational aids, port craft, equipment, Onshore facilities and layout, connectivity (i.e. with other ports of India & neighbouring

countries) etc. — and their project estimates thereafter.

- d. To **carry out a detailed layout** and cost estimate: Preparation of detailed layout plan along with detailed design & drawings, technical specifications and bill of quantities (BOQ) & cost estimates for the Port, internal road, drainage, breakwater and other utilities for executing the work.
- e. **Tariff and Revenue Estimates** with tariff assumptions in line with competitive tariffs in the neighbouring transshipment facilities especially Vizhinjam, Sri-Lanka etc. To carry out comparison of total logistic cost with other neighbouring transshipment facilities.
- f. **The consultant shall carry out detailed Financial Analysis** with a view to estimate the likely IRR for the project, sensitivity analysis including varying project cost and benefits. The consultant is required to make reasonable assumptions and discuss various scenarios and options like total investment by the Government or total investment by PPP operator or a hybrid model. The tariff to be in line with the Major Port Guidelines & shall be discussed with VOC Port for adoption.
- g. **Stakeholder consultation** — As part of the primary data collection and initial analysis of the project, the Consultant will be required to undertake a consultation with the stakeholders (international shipping lines, feeder operators, terminal operators) to understand the potential and acceptability of the project and to validate the assumptions made for the project and understand.
- h. **Investment plan and financing options** — The Consultant will also prepare a detailed investment plan, highlighting the priority investment components for the short term, medium and for the long term. The investment plan will set out activity phase specific timelines/timetables, responsibilities and mechanisms, based on the demand forecasts and an assessment of financing options and funding resources to service the financing.
- i. **Action plan and implementation schedule** — The Consultant shall be responsible for providing a clear action plan and implementation schedule based on the above study.

### 1.3 Request for Proposal

The Authority invites Proposals (the “**Proposals**”) for selection of consultant for Preparation of Detailed Project Report who shall provide engineering consultancy services towards the implementation of the



Project. The Consultancy service is for Preparation of Detailed Project Report & undertake other activities in conformity with the TOR. (Collectively the “**Consultancy**”).

#### 1.4 **Due diligence by Applicants**

Applicants are encouraged to inform themselves fully about the assignment and the local conditions before submitting the Proposal.

#### 1.5 **Validity of the Proposal**

The Proposal shall be valid for a period of not less than **120 days** from the Proposal Due Date (the “PDD”).

#### 1.6 **Brief description of the Selection Process**

The Authority has adopted a two-stage selection process (collectively the “**Selection Process**”) in evaluating the Proposals comprising technical and financial bids submitted. In the first stage, a technical evaluation will be carried out as specified in Clause 28.1. Based on this technical evaluation, a list of qualified applicants shall be prepared. In the second stage, a financial evaluation will be carried out as specified in Clause 28.3. The combined scoring system shall be adopted as brought in Clause 28.3. The Applicant who secures highest combined score for Consultancy Services shall be declared as the selected Applicant (the “Selected Applicant”).

## 2 INSTRUCTIONS TO APPLICANTS GENERAL

### 2.1 Scope of Proposal: (Please refer Schedule-1)

#### TERMS OF REFERENCE AND SCOPE OF WORK

##### I. Background:

V.O. Chidambaranar Port Authority (VOCPA), Tuticorin an autonomous body under the Ministry of Ports, Shipping and Waterways, Government of India, is undertaking various port infrastructure and modernization projects through Public-Private Partnership (PPP), HAM and EPC modes.

As a part of this V.O.Chidambaranar Port Authority (VOCPA), Tuticorin has envisaged development of Ship-building yard and Upgradation of the berths in the inner harbour through Strengthening and Mechanization.

##### II. Objectives:

1. The primary objective of the consultancy service is to prepare a Detailed Project Report for the following projects at V.O. Chidambaranar Port, Tuticorin:
  - i. Ship-building yard inside the Port
  - ii. Mechanization of Berth 7
  - iii. Mechanization of Berth 10
  - iv. Strengthening and Mechanization of Berths 3 & 4
  - v. Strengthening and Mechanization of Berths 1, 2, 5 & 6
2. Summary of tasks what an Internationally recognized consultant is expected to perform:
  - a. To assess / re-assess the current and future demand for the proposed facility including competition analysis vis-à-vis other trans-shipment facilities in neighbouring areas and divert ability of the traffic.
  - b. Review and incorporate the findings of previous studies undertaken for the project. Focus areas for the study include – Demand assessment of Transshipment Traffic and Gateway Traffic, approaches to improve Transshipment Traffic, evaluation of amount of investment, optimum vessel fleet required, preliminary social assessment, Environment sustainability plan (if made), **funding and financing arrangements** for construction and operations.
  - c. Tariff and Revenue Estimates with tariff assumptions in line with competitive tariffs in the neighbouring facilities especially Vizhinjam, Sri-Lanka etc. To carry out a comparison of total logistic cost with other neighbouring facilities.

- d. The consultant shall carry out detailed Financial Analysis with a view to estimate the likely IRR for the project, sensitivity analysis including varying project cost and benefits. The consultant is required to make reasonable assumptions and discuss various scenarios and options like total investment by PPP operator or hybrid model viz. Construction of breakwater and dredging & reclamation through HAM and rest through PPP or Construction of breakwater and dredging & reclamation through EPC by port with grant from Ministry and rest through PPP etc.
- e. Stakeholder consultation – As part of the primary data collection and initial analysis of the project, the Consultant will be required to undertake a consultation with the stakeholders (international shipping lines, feeder operators, terminal operators) to understand the potential and acceptability of the project and to validate the assumptions made for the project and understand.
- f. Investment plan and financing options – The Consultant shall also prepare a detailed investment plan, highlighting the priority investment components for the short term, medium and for the long term. The investment plan will set out activity phase specific timelines / timetables, responsibilities and mechanisms, based on the demand forecasts and an assessment of financing options and funding resources to service the financing.
- g. Action plan and implementation schedule – The Consultant shall be responsible for providing a clear action plan and implementation schedule based on the above study.

### **III. Scope of Work:**

1. **Study / Review of available earlier Reports** The consultant shall examine the following available earlier studies / reports carried out at VOC Port, Tuticorin.
  - a) DPR prepared by L&T, Chennai.
  - b) Strengthening of berths report by IITM, Chennai.
  - c) Master Plan 2047 for VOC Port Authority prepared by the consultants.
  - d) Hydrographic & oceanographical survey (Tide, current and wave measurement), geo-technical investigation and metrological survey

#### **2. Data Collection**

Data collection on the project would include the following:

- a. Secondary data collection – Collection of all secondary data and reports available with Central Government, State Government and local bodies
  - i. Data pertaining to neighbouring transshipment facilities especially Vizhinjam and Sri Lanka which would include temporal / trend data on

traffic, tariff, port infrastructure growth – Berth Information, Backup area, warehousing, depth, vessel berthing information and landside approach infrastructure.

**b. Primary data collection –**

- i. Technical surveys including topographic survey, for which the data is not available through secondary source or fresh surveys are required.
- ii. Site visits, market interviews, stakeholder consultation (with shipping lines, port operators, port authorities of major ports and State Maritime Boards, regulators, transporters, freight forwarders, feeder vessel operators etc.), temporal / trend traffic and technical (infrastructure) data from the Major Port Authorities and State Maritime Boards, collection of additional data.
- c. All the data collection primary or secondary shall be the responsibility of the Consultant.

**3. Data Assessment**

The data collected from the primary and secondary sources shall be assessed in terms of demand estimation and technical assessment.

- a. Technical / Supply side assessment
  - i. Prepare detailed hydrographic and geo-technical survey analysis
  - ii. Identify the requirement of technical interventions required including dredging, breakwater, reclamation, etc.
  - iii. Supply side analysis – Determine the maximum capacity for which the facility can be designed taking into consideration the following
    - approach infrastructure requirement and constraints,
    - land availability
    - maximum traffic potential, etc.
  - iv. Comparative assessment of supply side w.r.t to the neighbouring transshipment facilities especially of Vizhinjam and Sri Lanka. The assessment shall be carried out in terms of berth length, berth occupancy and utilization, backup area, warehousing, etc.
  - v. Any other technical analysis as required.

#### **4. Design and Detailing of the Project**

##### **a) Design Criteria**

Prepare design criteria of each and every marine and onshore facility, utilities etc. keeping in view performance criteria, functional requirements, design vessels, design loads, load combinations etc.

##### **b) Shipbuilding yard**

- (i) The proposed shipbuilding yard land area identified inside the Port shall be checked for technical feasibility.
- (ii) Required Land survey has to be carried out by the Consultant.
- (iii) Consultant has to assess minimum land area required for development of Shipbuilding yard.
- (iv) Minimum waterfront length / area required has to be analyzed and indicated in details drawings and report.
- (v) Consultant to take reconnaissance survey of the full area of identified location for development of Shipbuilding yard facilities.
- (vi) The consultant shall propose the Shipbuilding yard infrastructure with floating dock (floating out) / fixed dry dock / any other suitable technology for the proposed location and also set up Ship repair maintenance facility.
- (vii) To assess the setting up of viable International size Ship yard.
- (viii) Consultant has to analysis if dredging required for slipway of ships and indicate the in the drawing in details.
- (ix) Consultant to suggest technical criteria like sizes of ships to be built, size and number of dry docks, berthing area, layout of shipyard, equipment's required.
- (x) Consultant has to be carryout all survey such as Geo-technical Investigation, Hydraulic, Geological, Hydrographic etc. for design of various Infrastructure development area.
- (xi) The detailed layout drawing of slipway facility and other various facilities like revetment / Bank protection work, ship lifting facility, winches, equipment to handle ship and its parts, ship repair yard, painting area, work shop, store, hard stand, office building,

internal road, water supply, firefighting, electricity etc.

- (xii) Design of docks, berths and other structures proposed.
- (xiii) Detailed layout plan, Engineering Design & drawings, preparing specifications, bill of quantities, cost estimates with basis & justification of rates.
- (xiv) Estimated cost of development should be realistic and based on local schedule of rates / market rate and their basis / documentary proof should be included in the DPR with necessary details.
- (xv) Ascertain types and sizes of ships to be handled at the shipbuilding yard and repair facility, time frame, handling methods, constraints, etc.
- (xvi) Suggest indicative rates, the O & M operator of the Slipway should charge for undertaking various repair works at the Slipway.
- (xvii) Preparation of contract / tender document for selecting O&M operator of shipbuilding yard and repair facility through an open tender.
- (xviii) Preparation of project approval note / cabinet note etc.
- (xix) Consultant has to be indicated in the layout drawing all the facilities locate such as plate stock area, cutting area, fabrication area, unit assembly area, sub assembly area, grand assembly area, outlifting area, paint shelter and docks etc.

c) Design of Berth Structures

Detailed Design of berth structures including piles and super structure, tentative reinforcement details, founding levels and preparation of connected drawings (longitudinal and cross sections) for all the elements of the berthing & marine structure. The engineering shall also include provision of bollards, fenders, ladders etc. for smooth berthing operations.

d) Design of Dredging and Reclamation

Fixation of keel clearances for design vessels, depths of dredging in approach channel, turning circle, berth areas, & all maneuvering areas, computation of dredging & reclamation quantities with supporting calculations, dredging methods, details of reclamation / dumping grounds by matching the dredged

quantity with reclamation quantity for economic optimization etc. Design of reclamation areas for the superimposed loads meeting the design and performance criteria. Sourcing of reclamation materials, if there is shortfall vis-a-vis dredged quantity may be indicated.

e) Design of Operational areas, Container Yard

Detailed Design of Operational areas, Container Yard, design of terminal pavements, and foundation for equipment and buildings, receipt and delivery areas.

f) Design of Utilities

Detailed Design including general arrangements and typical cross sections of all internal roads, water supply (including quantity and source), sewerage, rainwater drainage system, landscaping, lighting, firefighting, IT and communications.

g) Design of Port Buildings

Design & Detailed Engineering of the Admin building, Security building, pump house, firefighting, substation, workshop, canteen & store, STP and others including Parking areas, In & Out Gates etc.

h) Specifications of Mechanization Equipment

Detailed specifications of cargo (containers / dry bulk / breakbulk) handling equipment at berth and Container yard shall be prepared to enable procurement.

i) Specifications of Port Crafts

The consultant shall assess the requirements of Port crafts required for the project to perform the various marine related activities over the development and operational phases of the port and prepare detailed specifications for the purpose of procurement.

j) Design of Electrical Distribution System

The consultant shall assess the requirements of Mechanical and Electrical Works, supply of power, identification of source & carry out detailed engineering of electrical works and furnish drawing based on the demand load. Emphasis to be given on renewable energy.



k) Design of Strengthening of berths

- i) Carry out stability analysis of existing block wall structure and proposed additional structure to be integrated with existing structure for **17.50m** dredge depth.
- ii) Carry out mooring analysis to determine the bollards capacity required for mooring of 2,00,000 DWT vessels.
- iii) Carry out berthing analysis to determine the fender size for berthing of vessels 2,00,000 DWT.
- iv) Design of various components of the additional berth structure and the connection to the existing block wall to transfer the mooring and fender loads.
- v) Prepare detailed drawings for piles, pile muff, beams and deck slab including shear connections to the existing block wall.
- vi) Prepare bill of quantities, rate analysis and cost estimate.
- vii) Preparation and submission of Good for Construction drawings along with detailed design.

**Note** – The Consultant is required to prepare the detailed specifications and data sheets of equipment pertaining to the above components of the project and share the same as part of the deliverables at required stages.

5. **Project Cost and Detailed Bill of Quantities (BoQ)**

- a. Cost estimates shall include capital and O&M costs. This shall also include the costs of all equipment including insurance, freight and erection.
- b. Preparation of Dredging estimate as per the prevailing Dredging Guidelines.
- c. The Cost Estimate shall also include the cost of road and rail connectivity required for the development of the project.

The Consultant shall review the detailed Bill of Quantities (BoQ) with technical specifications for all project components including marine structures, equipment, yard, & utilities with supporting calculations and prepare cost estimates of the Project with a break-down cost for each component separately, detailed BoQ of cost estimate for road network, rail network & utilities should also be included.

## **6. Tariff and Revenue Estimates**

- a. Assumption of tariff based on the following:
  - i. Comparative analysis of tariffs in the neighbouring similar ports and transshipment terminals including existing and temporal / trend analysis.
  - ii. Existing regulatory aspects and possible regulatory assumptions in the future shall be provided.
- b. A possible tariff structure shall be proposed
- c. Revenue based on tariffs and traffic shall be estimated

## **7. Financial modelling and structuring of the project**

The consultant shall prepare / update detailed financial model for the various options for the concession period of 30 years. The consultant shall provide an assessment of the financial viability of each of the projects.

The consultant shall conduct detailed financial analysis of the investment required phase-wise and overall investment year-wise (2026-2055), debt equity ratio, IRR / FIRR, break even analysis, sensitivity analysis, sources of funds etc. The consultant shall deploy a team to collect and calculate elements of operating cost from the industry and all revenue streams so as to make a proper estimate of cash inflows.

**The financial structuring of the project shall be taken into account;**

- I. Project timelines
- II. Project capital cost & phasing
- III. O & M costs
- IV. Tariff setting
- V. Revenue computations / year-wise
- VI. Funding pattern – various options
- VII. Tax & depreciation.

### **NPV & FIRR for the project**

The consultant shall calculate/update the NPV & FIRR for the project. It will undertake sensitivity analysis by identifying the most critical factors and determine their impact on the FIRR, including varying project costs, revenue earnings, implementation period & combination of these factors. The debt equity structure along with sensitivity analysis may be carried out along with Economic IRR for the project.

## **8. Socio-Economic Assessment**

The Consultant shall have proper co-ordination & consultation with the NGOs / Social Agencies engaged for community outreach at field level with regard to project interventions and devise the infrastructure in complete satisfaction of the local communities.

Accordingly, the Consultant shall assess the following:

- i. Direct employment during construction and post construction.
- ii. Potential economic development and increase in employment opportunities in the region / hinterland of project.
- iii. The economic potential of the region shall be assessed. Economic Performance Index (EPI) shall be assessed and provided along with effect of development on EPI; and
- iv. Potential social effects include consideration of health, demographic, employment and generated wealth on account of the potential traffic.

## **9. Execution Plans & Implementation Schedule**

The consultant shall prepare phase-wise execution plans. The implementation schedule in phases shall also be prepared in the form of bar chart.

## **10. Preparation of DPR**

The consultant shall assess the available data & prepare a detailed project report. The scope shall include but not limited to the following.

The consultant shall prepare a procurement strategy to decide the number of contract packages. For each contract package, the consultant shall prepare tender documents either on EPC basis, HAM model, PPP model etc.

#### **11. Tendering Process up to selection of Contractor(s)**

- i. Recommendation of agencies with necessary credentials who can undertake the execution of each of the packages furnishing list of recommended / shortlisted contractors / agencies suitable for executing the work(s).
- ii. Consultant shall participate in pre-bid meeting to assist the Authority along with the bidders for the various packages and shall respond to queries of the bidders through Authority.
- iii. The Consultant shall carryout detail technical and financial review of bids which will include, scrutiny of various technical documents like DBR, preliminary engineering / design calculations and drawings, general design aspects, performance guarantees and QAP of various equipment of these systems, general arrangements, drawings etc and project planning and scheduling documents submitted by bidders with their bids to ensure that the bids are in conformity with tender specifications and with prevailing engineering practices adopted for such facilities

### **3 Conflict of Interest**

- 3.1 An Applicant shall not have a conflict of interest that may affect the Selection Process or the Consultancy (the “**Conflict of Interest**”). Any Applicant found to have a Conflict of Interest shall be disqualified. In the event of disqualification, the Authority shall forfeit and appropriate the Bid Security as mutually agreed genuine pre-estimated compensation and damages payable to the Authority for, inter alia, the time, cost and effort of the Authority including consideration of such Applicant’s Proposal, without prejudice to any other right or remedy that may be available to the Authority hereunder or otherwise.
- 3.2 The Authority requires that the Consultant provides professional, objective, and impartial advice and at all times hold the Authority’s interests paramount, avoid conflicts with other assignments or its own interests, and act without any consideration for future work. The Consultant shall not accept or engage in any assignment that would be in conflict with its prior

or current obligations to other clients, or that may place it in a position of not being able to carry out the assignment in the best interests of the Authority.

3.3 Some guiding principles for identifying and addressing Conflicts of Interest have been illustrated in the Guidance Note at Schedule-3. Without limiting the generality of the above, an Applicant shall be deemed to have a Conflict of Interest affecting the Selection Process, if:

- a) the Applicant, its consortium member (the “**Member**”) or Associate (or any constituent thereof) and any other Applicant, its consortium member or Associate (or any constituent thereof) have common controlling shareholders or other ownership interest; provided that this disqualification shall not apply in cases where the direct or indirect shareholding or ownership interest of an Applicant, its Member or Associate (or any shareholder thereof having a shareholding more than 5 per cent of the paid up and subscribed share capital of such Applicant, Member or Associate, as the case may be) in the other Applicant, its consortium member or Associate is less than 5% (five per cent) of the subscribed and paid up equity share capital thereof; provided further that this disqualification shall not apply to any ownership by a bank, insurance company, pension fund or a public financial institution referred to in section 4A of the Companies Act, 1956. For the purposes of this Clause, indirect shareholding held through one or more intermediate persons shall be computed as follows: (aa) where any intermediary is controlled by a person through management control or otherwise, the entire shareholding held by such controlled intermediary in any other person (the “**Subject Person**”) shall be taken into account for computing the shareholding of such controlling person in the Subject Person; and (bb) subject always to sub-clause (aa) above, where a person does not exercise control over intermediary, which has shareholding in the Subject Person, the computation of indirect shareholding of such person in the Subject Person shall be undertaken on a proportionate basis; provided, however, that no such shareholding shall be reckoned under this sub-clause (bb) if the shareholding of such person in the intermediary is less than 26% (twenty six per cent) of the subscribed and paid up equity shareholding of such intermediary; or
- b) a constituent of such Applicant is also a constituent of another Applicant; or
- c) such Applicant or its Associate receives or has received any direct or indirect subsidy or grant from any other Applicant or its Associate; or
- d) such Applicant has the same legal representative for purposes of this

Application as any other Applicant; or

- e) such Applicant has a relationship with another Applicant, directly or through common third parties, that puts them in a position to have access to each others' information about, or to influence the Application of either or each of the other Applicant; or
- f) there is a conflict among this, and other consulting assignments of the Applicant (including its personnel and Sub-consultant) and any subsidiaries or entities controlled by such Applicant or having common controlling shareholders. The duties of the Consultant will depend on the circumstances of each case. While providing consultancy services to the Authority for this particular assignment, the Consultant shall not take up any assignment that by its nature will result in conflict with the present assignment; or
- g) a firm which has been engaged by the Authority to provide goods or works or services for a project, and its Associates, will be disqualified from providing consulting services for the same project save and except as provided in Clause 5; conversely, a firm hired to provide consulting services for the preparation or implementation of a project, and its Members or Associates, will be disqualified from subsequently providing goods or works or services related to the same project; or
- h) the Applicant, its Member or Associate (or any constituent thereof), and the bidder or Concessionaire, if any, for the Project, its contractor(s) or sub- contractor(s) (or any constituent thereof) have common controlling shareholders or other ownership interest; provided that this disqualification shall not apply in cases where the direct or indirect shareholding or ownership interest of an Applicant, its Member or Associate (or any shareholder thereof having a shareholding of more than 5% (five per cent) of the paid up and subscribed share capital of such Applicant, Member or Associate, as the case may be,) in the bidder or Concessionaire, if any, or its contractor(s) or sub-contractor(s) is less than 5% (five per cent) of the paid up and subscribed share capital of such Concessionaire or its contractor(s) or sub-contractor(s); provided further that this disqualification shall not apply to ownership by a bank, insurance company, pension fund or a Public Financial Institution referred to in section 4A of the Companies Act, 1956. For the purposes of this sub-clause (h), indirect shareholding shall be computed in accordance with the provisions of sub-clause (a) above.

For purposes of this RFP, Associate means, in relation to the Applicant, a person who controls, is controlled by, or is under the common control with such Applicant (the "Associate"). As used in this definition, the expression

“control” means, with respect to a person which is a company or corporation, the ownership, directly or indirectly, of more than 50% (fifty per cent) of the voting shares of such person, and with respect to a person which is not a company or corporation, the power to direct the management and policies of such person by operation of law or by contract.

- 3.4 An Applicant eventually appointed to provide Consultancy for this Project, and its Associates, shall be disqualified from subsequently providing goods or works or services related to the construction and operation of the same Project and any breach of this obligation shall be construed as Conflict of Interest; provided that the restriction herein shall not apply after a period of 5 (five) years from the completion of this assignment or to consulting assignments granted by banks/ lenders at any time; provided further that this restriction shall not apply to consultancy/ advisory services performed for the Authority in continuation of this Consultancy or to any subsequent consultancy/ advisory services performed for the Authority in accordance with the rules of the Authority. For the avoidance of doubt, an entity affiliated with the Consultant shall include a partner in the Consultant’s firm or a person who holds more than 5% (five per cent) of the subscribed and paid up share capital of the Consultant, as the case may be, and any Associate thereof.

### **3.5 Number of Proposals**

No Applicant or its Associate shall submit more than one Application for the Consultancy. An Applicant applying individually or as an Associate shall not be entitled to submit another application either individually or as a member of any consortium, as the case may be.

### **3.6 Cost of Proposal**

The Applicants shall be responsible for all of the costs associated with the preparation of their Proposals and their participation in the Selection Process including subsequent negotiation, visits to the Authority, Project site etc. The Authority will not be responsible or in any way liable for such costs, regardless of the conduct or outcome of the Selection Process.

### **3.7 Site visit and verification of information**

Applicants are encouraged to submit their respective Proposals after visiting the Project site and ascertaining for themselves the site conditions, location, surroundings, climate, access to the site, availability of drawings and other data with the Authority, Applicable Laws and regulations or any other matter considered relevant by them, at their own

cost.

#### **4 Acknowledgement by Applicant**

- 4.1 It shall be deemed that by submitting the Proposal, the Applicant has:
- a) made a complete and careful examination of the RFP;
  - b) received all relevant information requested from the Authority;
  - c) acknowledged and accepted the risk of inadequacy, error or mistake in the information provided in the RFP or furnished by or on behalf of the Authority or relating to any of the matters referred to in Clause 3.7 above;
  - d) satisfied itself about all matters, things and information, including matters referred to in Clause 3.7 herein above, necessary and required for submitting an informed Application and performance of all of its obligations thereunder;
  - e) acknowledged that it does not have a Conflict of Interest; and
  - f) agreed to be bound by the undertaking provided by it under and in terms hereof.

- 4.2 The Authority shall not be liable for any omission, mistake or error on the part of the Applicant in respect of any of the above or on account of any matter or thing arising out of or concerning or relating to RFP or the Selection Process, including any error or mistake therein or in any information or data given by the Authority.

#### **5 Right to reject any or all Proposals**

- 5.1 Notwithstanding anything contained in this RFP, the Authority reserves the right to accept or reject any Proposal and to annul the Selection Process and reject all Proposals, at any time without any liability or any obligation for such acceptance, rejection or annulment, and without assigning any reasons thereof.
- 5.2 Without prejudice to the generality of Clause 5.1, the Authority reserves the right to reject any Proposal if:
- a) at any time, a material misrepresentation is made or discovered, or
  - b) the Applicant does not provide, within the time specified by the Authority, the supplemental information sought by the Authority for evaluation of the Proposal.

Misrepresentation/ improper response by the Applicant may lead to the disqualification of the Applicant. If the Applicant is the Lead Member of a consortium, then the entire consortium may be disqualified / rejected. If such disqualification / rejection occurs after the Proposals have been opened and the highest-ranking Applicant gets disqualified / rejected, then the Authority reserves the right to consider the next best Applicant or take any other measure as may be deemed fit in the sole discretion of the Authority, including annulment of the Selection Process.

- d) Power of Attorney, if applicable, is executed as per Applicable Laws.

- e) CVs of all Professional Personnel have been included.
  - f) Key Personnel have been proposed only if they meet the Conditions of Eligibility laid down at Clause 28.1.3 of the RFP.
  - g) No alternative proposal for any Key Personnel is being made and only one CV for each position has been furnished.
  - h) The CVs have been recently signed and dated in blue ink by the respective Personnel and countersigned by the Applicant. Scanned / Digital signatures will also be considered.
  - i) The CVs shall contain an undertaking from the respective Key Personnel about his/her availability for the duration specified in the RFP.
  - j) Professional Personnel proposed have good working knowledge of English language;
  - k) Key Personnel would be available for the period indicated in the TOR.
  - l) No Key Personnel should have attained the age of 75 (seventy five) years at the time of submitting the proposal; and
  - m) The proposal is responsive in terms of Clause 17.3.
- 11.3 Failure to comply with the requirements spelt out in this Clause 11 shall make the Proposal liable to be rejected.
- 11.4 If an individual Key Personnel makes a false averment regarding his qualification, experience or other particulars, or his commitment regarding availability for the Project is not fulfilled at any stage after signing of the Agreement, he shall be liable to be debarred for any future assignment of the Authority for a period of 5 (five) years. The award of this Consultancy to the Applicant may also be liable to cancellation in such an event.
- 11.5 The Technical Proposal shall not include any financial information relating to the Financial Proposal.
- 11.6 The proposed team shall be composed of experts and specialists (the "Professional Personnel") in their respective areas of expertise and managerial/support staff (the "Support Personnel") such that the Consultant should be able to complete the Consultancy within the specified time schedule. The Key Personnel specified in Clause 2.1 IV shall be included in the proposed team of Professional Personnel. Other competent and experienced Professional Personnel in the relevant areas of expertise must be added as required for successful completion of this Consultancy. The CV of each such Professional Personnel, if any, should also be submitted in the format at Form-14 of Appendix-I.

- 11.7 An Applicant may, if it considers necessary, propose suitable Sub-Consultants in specific areas of expertise. Credentials of such Sub-Consultants should be submitted in Form-17 of Appendix-I. A Sub-Consultant, however, shall not be a substitute for any Key Personnel.
- 11.8 The Authority reserves the right to verify all statements, information and documents, submitted by the Applicant in response to the RFP. Any such verification or the lack of such verification by the Authority to undertake such verification shall not relieve the Applicant of its obligations or liabilities hereunder nor will it affect any rights of the Authority there under.
- 11.9 In case it is found during the evaluation or at any time before signing of the Agreement or after its execution and during the period of subsistence thereof, that one or more of the eligibility conditions have not been met by the Applicant or the Applicant has made material misrepresentation or has given any materially incorrect or false information, the Applicant shall be disqualified forthwith if not yet appointed as the Consultant either by issue of the LOA or entering into of the Agreement, and if the Selected Applicant has already been issued the LOA or has entered into the Agreement, as the case may be, the same shall, notwithstanding anything to the contrary contained therein or in this RFP, be liable to be terminated, by a communication in writing by the Authority without the Authority being liable in any manner whatsoever to the Applicant or Consultant, as the case may be.
- 11.10 In such an event, the Authority shall forfeit and appropriate the Bid Security as mutually agreed pre-estimated compensation and damages payable to the Authority for, inter alia, time, cost and effort of the Authority, without prejudice to any other right or remedy that may be available to the Authority.

## **12 Financial Proposal**

- 12.1 Applicants shall submit the financial proposal in the excel sheet in CPP Portal and also in the formats at Appendix-II (the "Financial Proposal") clearly indicating the total cost of the Consultancy (Form-2 of Appendix-II) in both figures and words, in Indian Rupees, and signed by the Applicant's Authorized Representative. In the event of any difference between figures and words, the amount indicated in words shall prevail. In the event of a difference between the arithmetic total and the total shown in the Financial Proposal, the lower of the two shall prevail.
- 12.2 While submitting the Financial Proposal, the Applicant shall ensure the following:
- i. All the costs associated with the assignment shall be included in the Financial Proposal. These shall normally cover remuneration for all the Key

Personnel, accommodation, air fare, equipment, printing of documents, surveys, verification of available record and taking photocopies of available document etc. The total amount indicated in the Financial Proposal shall be without any condition attached or subject to any assumption and shall be final and binding. In case any assumption or condition is indicated in the Financial Proposal, it shall be considered non-responsive and liable to be rejected.

- ii. The Financial Proposal shall take into account all expenses and tax liabilities excluding service tax. The service tax will be reimbursed as per actual after submission of paid receipt by the consultant. For the avoidance of doubt, it is clarified that all taxes shall be deemed to be included in the costs shown under different items of the Financial Proposal. Further, all payments shall be subject to deduction of taxes at source as per Applicable Laws.
- iii. Costs (including breakdown of costs) shall be expressed in INR.

### **13 Submission of Proposal**

- 13.1 The completed Proposal must be uploaded on or before the specified time on Proposal Due Date. Proposals submitted by fax, telex, telegram or e-mail shall not be entertained.
- 13.2 The rates quoted shall be firm throughout the period of performance of the assignment upto and including acceptance of the Detailed Project Report by the Authority and discharge of all obligations of the Consultant under the Agreement.

### **14 Proposal Due Date**

- 14.1 Proposal should be submitted at or before 15:00 hrs on the Proposal Due Date specified in Clause 1.7 in the CPP Portal as detailed in this RFP.
- 14.2 The Authority may, in its sole discretion, extend the Proposal Due Date by issuing an Addendum in accordance with Clause 8 uniformly for all Applicants.

### **15 BID SECURITY (Earnest Money Deposit)**

- 15.1 The Applicant shall furnish as part of its Proposal, a bid security of Rs.10,00,000/- (Rupees Ten Lakhs only) (the "Bid Security") through CPP Portal. The EMD shall also be furnished in the form of Bank Guarantee (format enclosed). The original Bank Guarantee should reach the Port within Ten days from the date of opening of technical bid under Registered Post (A.D). The EMD is exempted to MSE consultants. The bid security of unsuccessful bidder will be refunded within one month on finalization of bid except in case of the two highest ranked Applicants as required in Clause 20.1.

- 15.2 In the event that the first ranked Applicant commences the assignment as required in Clause 25, the second ranked Applicant, who has been kept in reserve, shall be returned its Bid Security forthwith, but in no case not later than 120 (one hundred and twenty) days from PDD. The Selected Applicant's Bid Security shall be adjusted in the Security Deposit.
- 15.3 The Authority shall not be liable to pay any interest on the Bid Security and the same shall be interest free.
- 15.4 The Applicant, by submitting its Application pursuant to this RFP, shall be deemed to have acknowledged that without prejudice to the Authority's any other right or remedy hereunder or in law or otherwise, the Bid Security shall be forfeited and appropriated by the Authority as the mutually agreed pre-estimated compensation and damage payable to the Authority for, inter alia, the time, cost and effort of the Authority in regard to the RFP including the consideration and evaluation of the Proposal under the following conditions:
- a) If an Applicant submits a non-responsive Proposal;
  - b) If an Applicant engages in any of the Prohibited Practices specified in Section 4 of this RFP;
  - c) If an Applicant withdraws its Proposal during the period of its validity as specified in this RFP and as extended by the Applicant from time to time;
  - d) In the case of the Selected Applicant, if the Applicant fails to reconfirm its commitments during negotiations as required vide Clause 20.1;
  - e) In the case of a Selected Applicant, if the Applicant fails to sign the Agreement or commence the assignment as specified in Clauses 24 and 25 respectively; or
  - f) If the Applicant is found to have a Conflict of Interest as specified in Clause 25.

## **16 Performance Security**

- 16.1 The Applicant, by submitting its Application pursuant to this RFP, shall be deemed to have acknowledged that without prejudice to the Authority's any other right or remedy hereunder or in law or otherwise, its Performance Security shall be forfeited and appropriated by the Authority as the mutually agreed pre-estimated compensation and damages payable to the Authority for, inter alia, the time, cost and effort of the Authority in regard to the RFP, including the consideration and evaluation of the Proposal, under the following conditions:
- a) If an Applicant engages in any of the Prohibited Practices specified in Clause 29 of this RFP;

b) if the Applicant is found to have a Conflict of Interest as specified in Clause 3; and

c) If the Selected Applicant commits a breach of the Agreement.

16.2 An amount equal to 5% (five per cent) of the Agreement Value shall be deemed to be the Performance Security for the purposes of this Clause 16.1, which may be forfeited and appropriated in accordance with the provisions hereof.

## **EVALUATION PROCESS**

### **17 Evaluation of Proposals**

17.1 The Technical Bids will be opened on 24.09.2025 at 15.30 hrs. The pre-qualified bidders "Financial Proposal" shall be opened at later date.

17.2 Prior to evaluation of Proposals, the Authority will determine whether each Proposal is responsive to the requirements of the RFP. The Authority may, in its sole discretion, reject any Proposal that is not responsive hereunder. A Proposal shall be considered responsive only if:

a) The Technical Proposal is received in the form specified at Appendix-I ();

b) It is accompanied by the Bid Security as specified in Clause 15.

c) It is accompanied by the Power of Attorney as specified in Clause 10.2;

d) It contains all the information (complete in all respects) as requested in the RFP;

e) It does not contain any condition or qualification; and

f) It is not non-responsive in terms hereof.

17.3 The Authority reserves the right to reject any Proposal which is non-responsive and no request for alteration, modification, substitution or withdrawal shall be entertained by the Authority in respect of such Proposals.

17.4 The Authority shall subsequently examine and evaluate Proposals in accordance with the Selection Process specified at Clause 1.6 and the criteria set out in clause 28 of this RFP.

17.5 After the technical evaluation, the Authority shall prepare a list of pre-qualified and shortlisted Applicants in terms of Clause 28.2 for opening of their Financial Proposals. A date, time and venue will be notified to all Applicants for announcing the result of evaluation and opening of Financial Proposals. Before opening of the Financial Proposals, the list of pre-

qualified and shortlisted Applicants along with their Technical Score will be read out. The opening of Financial Proposals shall be done in presence of respective representatives of Applicants who choose to be present. The Authority will not entertain any query or clarification from Applicants who fail to qualify at any stage of the Selection Process. The financial evaluation and final ranking of the Proposals shall be carried out in terms of Clause 28.3.

- 17.6 Applicants are advised that selection shall be entirely at the discretion of the Authority. Applicants shall be deemed to have understood and agreed that the Authority shall not be required to provide any explanation or justification in respect of any aspect of the Selection Process or Selection.
- 17.7 Any information contained in the Proposal shall not in any way be construed as binding on the Authority, its agents, successors or assigns, but shall be binding against the Applicant if the Consultancy is subsequently awarded to it.

## **18 Confidentiality**

Information relating to the examination, clarification, evaluation, and recommendation for the selection of Applicants shall not be disclosed to any person who is not officially concerned with the process or is not a retained professional adviser advising the Authority in relation to matters arising out of, or concerning the Selection Process. The Authority will treat all information, submitted as part of the Proposal, in confidence and will require all those who have access to such material to treat the same in confidence. The Authority may not divulge any such information unless it is directed to do so by any statutory entity that has the power under law to require its disclosure or is to enforce or assert any right or privilege of the statutory entity and/or the Authority.

## **19 Clarifications**

- 19.1 To facilitate evaluation of Proposals, the Authority may, at its sole discretion, seek clarifications from any Applicant regarding its Proposal. Such clarification(s) shall be provided within the time specified by the Authority for this purpose. Any request for clarification(s) and all clarification(s) in response thereto shall be in writing.
- 19.2 If an Applicant does not provide clarifications sought under Clause 19.1 above within the specified time, its Proposal shall be liable to be rejected. In case the Proposal is not rejected, the Authority may proceed to evaluate the Proposal by construing the particulars requiring clarification to the best of its understanding, and the Applicant shall be barred from subsequently



questioning such interpretation of the Authority.

## **20 APPOINTMENT OF CONSULTANT**

- 20.1 **Negotiations:** The Selected Applicant may, if necessary, be invited for negotiations. The negotiations shall generally not be for reducing the price of the Proposal, but will be for re-confirming the obligations of the Consultant under this RFP. Issues such as deployment of Key Personnel, understanding of the RFP, methodology and quality of the work plan shall be discussed during negotiations. Key Personnel who did not score 60% (sixty per cent) marks as required under Clause 28.1.2 shall be replaced by the Applicant with a better candidate to the satisfaction of the Authority. In case the Selected Applicant fails to reconfirm its commitment, the Authority reserves the right to designate the Applicant scoring second highest combined score as the Selected Applicant and invite it for negotiations.
- 20.2 The Authority will examine the CVs of all other Professional Personnel and those not found suitable shall be replaced by the Applicant to the satisfaction of the Authority.
- 20.3 The Authority will examine the credentials of all Sub-Consultants proposed for this Consultancy and those not found suitable shall be replaced by the Applicant to the satisfaction of the Authority.

## **21 Substitution of Key Personnel**

- 21.1 The Authority will not normally consider any request of the Selected applicant for substitution of Key Personnel as the ranking of the Applicant is based on the evaluation of Key Personnel and any change therein may upset the ranking. Substitution will, however, be permitted if the Key Personnel is not available for reasons such as resignation, illness, accident, inadequate performance, or personality conflict, subject to equally or better qualified and experienced personnel being provided to the satisfaction of the Authority.
- 21.2 The Authority expects all the Key Personnel to be available during implementation of the Agreement. The Authority will not consider substitution of Key Personnel except for reasons of any incapacity or due to health. Such substitution shall ordinarily be limited to one Key Personnel subject to equally or better qualified and experienced personnel being provided to the satisfaction of the Authority. As a condition to such substitution, a sum equal to 2% (two per cent) of the remuneration specified for the original Key Personnel shall be deducted from the payments due to the Consultant. In the case of a second substitution hereunder, such deduction shall be 5% (five per cent) of the remuneration specified for the original Key Personnel. Any further substitution may lead to

disqualification of the Applicant or termination of the Agreement.

- 21.3 Substitution of the Team Leader will not normally be considered and may lead to disqualification of the Applicant or termination of the Agreement

## **22 Indemnity**

The Consultant shall, subject to the provisions of the Agreement, indemnify the Authority for an amount not exceeding the value of the Agreement for any direct loss or damage that is caused due to any deficiency in services.

The Consultant shall indemnify the Client against all legally enforceable claims, damages, losses or expenses arising out of or resulting from any gross negligence by the Consultant, his servants and agents in performing the Services provided always that the liability of the Consultant to indemnify the Client as aforesaid shall be reduced proportionately to the extent that any wrongful act or neglect of the Client, his servants and agents may have contributed to such claims, damages, losses or expenses. In the event of any errors or omissions for which the Consultant is responsible and as a result of which re-execution of the Services is required, the Consultant shall, without relieving any liability and obligation under this Agreement, at his own cost re-execute such Services to the reasonable satisfaction of the Client.

## **23 Award of Consultancy**

After selection, a Letter of Award (the "LOA") shall be issued, in duplicate, by the Authority to the Selected Applicant and the Selected Applicant shall, within 7 (seven) days of the receipt of the LOA, sign and return the duplicate copy of the LOA in acknowledgement thereof. In the event the duplicate copy of the LOA duly signed by the Selected Applicant is not received by the stipulated date, the Authority may, unless it consents to extension of time for submission thereof, appropriate the Bid Security of such Applicant as mutually agreed genuine pre-estimated loss and damage suffered by the Authority on account of failure of the Selected Applicant to acknowledge the LOA, and the next highest ranking Applicant may be considered.

## **24 Execution of Agreement**

After acknowledgement of the LOA as aforesaid by the Selected Applicant, it shall execute the Agreement within **15 (Fifteen) days**. The Selected Applicant shall not be entitled to seek any deviation in the Agreement.

## **25 Commencement of assignment**

The Consultant shall commence the Services at the Project site within 15 (fifteen) days of the date of issue of work order or such other date as may be mutually agreed. If the Consultant fails to either sign the Agreement as

specified in Clause 24 or commence the assignment as specified herein, the Authority may invite the Applicant submitting second lowest Financial Proposal for negotiations. In such an event, the Bid Security of the Selected Applicant shall be forfeited and appropriated in accordance with the provisions of Clause 15.4.

## **26 Proprietary data**

Subject to the provisions of Clause 5, all documents and other information provided by the Authority or submitted by an Applicant to the Authority shall remain or become the property of the Authority. Applicants and the Consultant, as the case may be, are to treat all information as strictly confidential. The Authority will not return any Proposal or any information related thereto. All information collected, analyzed, processed or in whatever manner provided by the Consultant to the Authority in relation to the Consultancy shall be the property of the Authority.

## **27 Time for completion:**

The assignment shall have the timeline vis-a vis the deliverables (as in Clause 2.1). In case of delay of assignment, the contract of consultancy may be extended suitably. In case of extension and foreclosure, pro-rata addition or deduction shall be entertained based on percentage indicated for the assignment. In case assignment foreclose in the middle of any indicated stage in the financial proposal, pro-rata payment shall be made for the completed services as agreed mutually. The period indicated above excludes the period taken by the employer and the concerned Govt Authorities.

At the discretion of Employer without assigning any reasons whatsoever, the assignment may foreclose at any stage. Consultant does not reserve any right to claim compensation whatsoever for foreclosure of consultancy contract by Employer.

## **28 CRITERIA FOR EVALUATION**

### **28.1 Evaluation of Technical Proposals**

28.1.1 In the first stage, the Technical Proposal will be evaluated on the basis of the Applicant's experience, its understanding of TOR, proposed methodology and Work Plan, and the experience of Key Personnel. Only those Applicants whose Technical Proposals score 60 (Sixty) marks or more out of 100 (one hundred) shall qualify for further consideration and shall be ranked from highest to the lowest on the basis of their technical score (TS).

28.1.2 Each Key Personnel must score a minimum of 60% (Sixty percent) marks

except as provided herein. A Proposal shall be rejected if the Team Leader scores less than 60% marks or any two of the remaining Key Personnel score less than 60% marks. In case the Selected Applicant has one Key Personnel, other than the Team Leader, who scores less than 60% marks, he would have to be replaced during negotiations, with a better candidate who, in the opinion of the Authority, would score 60% or above.

28.1.3 The Parameters for evaluation criteria is prepared as under.

**Eligible Assignments for Key personnel shall mean Projects for development of Port & Harbour costing Rs.1000 crore or more.**

#### **28.1.4 Eligible Assignments**

For the purposes for evaluating the Proposals under this RFP, consultancy assignments for the following project shall be deemed as eligible assignment (the “Eligible Assignments”):

##### **i. Technical Capacity**

The Bidder should have successfully completed at least one port project of DPR / Detailed Engineering for Port sector project having an estimated capital cost of at least Rs.1000 Crores in single project or two Port Projects of Detailed Engineering for Port sector project each having an estimated capital cost of at least Rs.700 Crores in the last 7 years ending last day of month previous to the one in which proposals are invited. For instance, Work Completion Certificate along with work order / LoA from the Client has to be furnished. In the absence of a completion certificate, a CA/SA certificate confirming 100% fee receipt may be submitted.

Port sector means: Port sector would be deemed to include composite works involving majority of works, on shore and off shore Terminals / Berth / Jetties / Quays, breakwaters and Cargo Handling & Storage system / Bulk / liquid Material Handling & Storage System.

##### **ii. Financial Capacity**

The Bidder shall have an average annual financial turnover during last three financial years (2021-22, 2022-23 & 2023-24) shall be at least Rs.5 Crore

(INR). For instance, Audited financials / balance sheets for last 3 financial years or SA / CA certificate has to be furnished.

iii. **Legal Status:**

The applicant should have a valid registration with appropriate authorities, such as the Registrar of Companies, and possess necessary tax registrations. For instance, Certificate of Incorporation / Registration and Proof of Tax registrations has to be furnished.

iv. **Net Worth:**

The Applicant should have a positive net worth in last financial year (FY 2023-24). For instance, CA/SA certified net worth statement (audited balance sheets, P&L account statements) shall be furnished.

v. **Not Blacklisted:**

The Applicant should not be blacklisted by any Central Govt./State Govt./PSU/Govt. Bodies in India. (Appendix I: Form 18-Self-declaration).

vi. **JV / Consortium:**

In case of JV / Consortium, max. number of members shall not exceed 4. Further, the Lead Member must meet at least 50% of turnover & experience criteria of at least one port project of DPR / Detailed Engineering for Port sector project having an estimated capital cost of not less than Rs.700 Crores. There must be a legally binding agreement clearly stipulating the responsibilities and liabilities of the members of the JV / Consortium. The average turnover of only those Members of the JV / Consortium shall be aggregated who meet such experience criteria.

vii. **Presence in India:**

In case Applicant is an international firm, registered outside India, the Applicant shall have presence / office in India. If not, the Applicant may tie up with a firm registered in India having experience of working on ports and maritime sector in India with Govt. sector clients to support in project as per ToR. For instance, Proof of office in India / Letter of Intent / Association with an Indian entity has to be furnished.

## 28.2 **Short-listing of Applicants**

Of the Applicant(s) whose technical score is equal to or more than 60 points shall be pre-qualified and short-listed for financial evaluation in the second stage. However, if the number of such pre-qualified Applicants is less than two, the Authority may, in its sole discretion, pre-qualify the Applicant(s)

whose technical score is less **than 60 points** even if such Applicant(s) do(es) not qualify in terms of Clause 28; provided that in such an event, the total number of pre-qualified and short-listed Applicants shall not exceed two.

### 28.3 Evaluation of Financial Proposal

28.3.1 In the second stage, the financial evaluation will be carried out as per this Clause 34.3.

28.3.2 After the opening of Financial proposals, the lowest financial proposal (FM) will be given a financial score (FS) of 100 points. The financial scores of other proposals will be computed as follows:

$$FS=100 \times FM/F$$

(Where F = Amount of financial proposal)

Proposals will finally be ranked according to their combined Technical (TS) and Financial (FS) scores as follows:

$$S = TS \times 0.8 + FS \times 0.2$$

Where 'S' is the combined score and weightages assigned to Technical Proposal and Financial Proposal shall be 0.80 and 0.20 respectively.

The qualified bidder who secures the highest combined score would be declared as the successful bidder. In the event that two or more bidders secure same combined score, the work will be awarded to the lowest price bidder.

28.3.3 The Authority will determine whether the Financial Proposals are complete, unqualified and unconditional. The cost indicated in the Financial Proposal shall be deemed as final and reflecting the total cost of services. Omissions, if any, in costing any item shall not entitle the firm to be compensated and the liability to fulfil its obligations as per the TOR within the total quoted price shall be that of the Consultant.

## 29 FRAUD AND CORRUPT PRACTICES

29.1 The Applicants and their respective officers, employees, agents and advisers shall observe the highest standard of ethics during the Selection Process. Notwithstanding anything to the contrary contained in this RFP, the Authority shall reject a Proposal without being liable in any manner whatsoever to the Applicant, if it determines that the Applicant has, directly or indirectly or through an agent, engaged in corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice (collectively the "**Prohibited Practices**") in the Selection Process. In such



an event, the Authority shall, without prejudice to its any other rights or remedies, forfeit and appropriate the Bid Security or Performance Security, as the case may be, as mutually agreed genuine pre-estimated compensation and damages payable to the Authority for, inter alia, time, cost and effort of the Authority, in regard to the RFP, including consideration and evaluation of such Applicant's Proposal.

29.2 Without prejudice to the rights of the Authority under Clause 29.1 hereinabove and the rights and remedies which the Authority may have under the LOA or the Agreement, if an Applicant or Consultant, as the case may be, is found by the Authority to have directly or indirectly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice during the Selection Process, or after the issue of the LOA or the execution of the Agreement, such Applicant or Consultant shall not be eligible to participate in any RFP or RFP issued by the Authority during a period of 2 (two) years from the date such Applicant or Consultant, as the case may be, is found by the Authority to have directly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice, as the case may be.

29.3 For the purposes of this Section, the following terms shall have the meaning hereinafter respectively assigned to them:

a) "corrupt practice" means (i) the offering, giving, receiving, or soliciting, directly or indirectly, of anything of value to influence the action of any person connected with the Selection Process (for avoidance of doubt, offering of employment to or employing or engaging in any manner whatsoever, directly or indirectly, any official of the Authority who is or has been associated in any manner, directly or indirectly with the Selection Process or the LOA or has dealt with matters concerning the Agreement or arising therefrom, before or after the execution thereof, at any time prior to the expiry of one year from the date such official resigns or retires from or otherwise ceases to be in the service of the Authority, shall be deemed to constitute influencing the actions of a person connected with the Selection Process); or (ii) save as provided herein, engaging in any manner whatsoever, whether during the Selection Process or after the issue of the LOA or after the execution of the Agreement, as the case may be, any person in respect of any matter relating to the Project or the LOA or the Agreement, who at any time has been or is a legal, financial or technical consultant/ adviser of the Authority in relation to any matter concerning the Project;

b) "fraudulent practice" means a misrepresentation or omission of facts

or disclosure of incomplete facts, in order to influence the Selection Process;

- c) “coercive practice” means impairing or harming or threatening to impair or harm, directly or indirectly, any persons or property to influence any person’s participation or action in the Selection Process;
- d) “undesirable practice” means (i) establishing contact with any person connected with or employed or engaged by the Authority with the objective of canvassing, lobbying or in any manner influencing or attempting to influence the Selection Process; or (ii) having a Conflict of Interest; and
- e) “Restrictive practice” means forming a cartel or arriving at any understanding or arrangement among Applicants with the objective of restricting or manipulating a full and fair competition in the Selection Process.

### **30 PRE-PROPOSAL CONFERENCE**

- 30.1 Pre-Proposal Conference of the Applicants shall be convened virtually at the designated date and time. Link will be sent to the bidders who show interest via mail. A maximum of two representatives of each Applicant shall be allowed to participate on production of an authority letter from the Applicant.
- 30.2 During the course of Pre-Proposal Conference, the Applicants will be free to seek clarifications and make suggestions for consideration of the Authority. The Authority shall endeavour to provide clarifications and such further information as it may, in its sole discretion, consider appropriate for facilitating a fair, transparent and competitive Selection Process.

### **31 MISCELLANEOUS**

- 31.1 The Selection Process shall be governed by, and construed in accordance with, the laws of India and the Courts at Tuticorin shall have exclusive jurisdiction over all disputes arising under, pursuant to and / or in connection with the Selection Process.
- 31.2 The Authority, in its sole discretion and without incurring any obligation or liability, reserves the right, at any time, to:
  - a) suspend and/or cancel the Selection Process and / or amend and / or supplement the Selection Process or modify the dates or other terms and conditions relating thereto;
  - b) consult with any Applicant in order to receive clarification or further

information;

- c) retain any information and/or evidence submitted to the Authority by, on behalf of and/or in relation to any Applicant; and/or
- d) Independently verify, disqualify, reject and/or accept any and all submissions or other information and/or evidence submitted by or on behalf of any Applicant.

- 31.3 It shall be deemed that by submitting the Proposal, the Applicant agrees and releases the Authority, its employees, agents and advisers, irrevocably, unconditionally, fully and finally from any and all liability for claims, losses, damages, costs, expenses or liabilities in any way related to or arising from the exercise of any rights and/or performance of any obligations hereunder, pursuant hereto and/or in connection herewith and waives any and all rights and/or claims it may have in this respect, whether actual or contingent, whether present or future.
- 31.4 All documents and other information supplied by the Authority or submitted by an Applicant shall remain or become, as the case may be, the property of the Authority. The Authority will not return any submissions made hereunder. Applicants are required to treat all such documents and information as strictly confidential.
- 31.5 The Authority reserves the right to make inquiries with any of the clients listed by the Applicants in their previous experience record.

**TERMS OF REFERENCE (TOR) FOR SELECTION OF CONSULTANT**

#### **I. Background:**

V.O. Chidambaranar Port Authority (VOCPA), Tuticorin an autonomous body under the Ministry of Ports, Shipping and Waterways, Government of India, is undertaking various port infrastructure and modernization projects through Public-Private Partnership (PPP), HAM and EPC modes.

As a part of this V.O.Chidambaranar Port Authority (VOCPA), Tuticorin has envisaged development of Ship-building yard and Upgradation of the berths in the inner harbour through Strengthening and Mechanization.

#### **II. Objectives:**

1. The primary objective of the consultancy service is to prepare a Detailed Project Report for the following projects at at V.O. Chidambaranar Port, Tuticorin.
  - i. Ship-building yard inside the Port
  - ii. Mechanization of Berth 7
  - iii. Mechanization of Berth 10
  - iv. Strengthening and Mechanization of Berths 3 & 4
  - v. Strengthening and Mechanization of Berths 1, 2, 5 & 6
2. Summary of tasks what an Internationally recognized consultant is expected to perform:
  - a. To assess / re-assess the current and future demand for the proposed facility including competition analysis vis-à-vis other trans-shipment facilities in neighbouring areas and divert ability of the traffic.
  - b. Review and incorporate the findings of previous studies undertaken for the project. Focus areas for the study include – Demand assessment of Transshipment Traffic and Gateway Traffic, approaches to improve Transshipment Traffic, evaluation of amount of investment, optimum vessel fleet required, preliminary social assessment, Environment sustainability plan (if made), **funding and financing arrangements** for construction and operations.

- c. Tariff and Revenue Estimates with tariff assumptions in line with competitive tariffs in the neighbouring facilities especially Vizhinjam, Sri-Lanka etc. To carry out a comparison of total logistic cost with other neighbouring facilities.
- d. The consultant shall carry out detailed Financial Analysis with a view to estimate the likely IRR for the project, sensitivity analysis including varying project cost and benefits. The consultant is required to make reasonable assumptions and discuss various scenarios and options like total investment by PPP operator or hybrid model viz. Construction of breakwater and dredging & reclamation through HAM and rest through PPP or Construction of breakwater and dredging & reclamation through EPC by port with grant from Ministry and rest through PPP etc.
- e. Stakeholder consultation – As part of the primary data collection and initial analysis of the project, the Consultant will be required to undertake a consultation with the stakeholders (international shipping lines, feeder operators, terminal operators) to understand the potential and acceptability of the project and to validate the assumptions made for the project and understand.
- f. Investment plan and financing options – The Consultant shall also prepare a detailed investment plan, highlighting the priority investment components for the short term, medium and for the long term. The investment plan will set out activity phase specific timelines / timetables, responsibilities and mechanisms, based on the demand forecasts and an assessment of financing options and funding resources to service the financing.
- g. Action plan and implementation schedule – The Consultant shall be responsible for providing a clear action plan and implementation schedule based on the above study.

### **III. Scope of Work:**

1. **Study / Review of available earlier Reports** The consultant shall examine the following available earlier studies / reports carried out at VOC Port, Tuticorin.
  - a) DPR prepared by L&T, Chennai.
  - b) Strengthening of berths report by IITM, Chennai.
  - c) Master Plan 2047 for VOC Port Authority prepared by the consultants.
  - d) Hydrographic & oceanographical survey (Tide, current and wave measurement), geo-technical investigation and metrological survey

#### **2. Data Collection**

Data collection on the project would include the following:

- a. Secondary data collection – Collection of all secondary data and reports available with Central Government, State Government and local bodies
  - i. Data pertaining to neighbouring transshipment facilities especially Vizhinjam and Sri Lanka which would include temporal / trend data on traffic, tariff structure, port infrastructure growth – Berth Information, Backup area, warehousing, depth, vessel berthing information and landside approach infrastructure.
- b. Primary data collection –**
  - i. Technical surveys including topographic survey, for which the data is not available through secondary source or fresh surveys are required. In case, bathymetry charts are not available or are not detailed, the survey needs to be carried out including side scan sonar image, sub-bottom profiling and magnetometer survey.
  - ii. Site visits, market interviews, stakeholder consultation (with shipping lines, port operators, port authorities of major ports and State Maritime Boards, regulators, transporters, freight forwarders, feeder vessel operators etc.), temporal / trend traffic and technical (infrastructure) data from the Major Port Authorities and State Maritime Boards, collection of additional data.
- c. All the data collection, primary or secondary shall be the responsibility of the Consultant.

#### **4. Data Assessment**

The data collected from the primary and secondary sources shall be assessed in terms of demand estimation and technical assessment.

- a. Technical / Supply side assessment
  - i. Prepare detailed hydrographic and geo-technical survey analysis
  - ii. Identify the requirement of technical interventions required including dredging, breakwater, reclamation, etc.
  - iii. Supply side analysis – Determine the maximum capacity for which the facility can be designed taking into consideration the following
    - approach infrastructure requirement and constraints,
    - land availability
    - maximum traffic potential, etc.
  - iv. Comparative assessment of supply side w.r.t to the neighbouring transshipment facilities especially of Vizhinjam and Sri Lanka. The

assessment shall be carried out in terms of berth length, berth occupancy and utilization, backup area, warehousing, etc.

- v. Any other technical analysis as required.

#### **4. Design and Detailing of the Project**

##### **a) Design Criteria**

Prepare design criteria of each and every marine and onshore facility, utilities etc. keeping in view performance criteria, functional requirements, design vessels, design loads, load combinations etc.

##### **b) Shipbuilding yard:**

- (i) The proposed shipbuilding yard land area identified inside the Port shall be checked for technical feasibility.
- (ii) Required Land survey has to be carried out by the Consultant.
- (iii) Consultant has to assess minimum land area required for development of Shipbuilding yard.
- (iv) Minimum waterfront length / area required has to be analyzed and indicated in details drawings and report.
- (v) Consultant to take reconnaissance survey of the full area of identified location for development of Shipbuilding yard facilities.
- (vi) The consultant shall propose the Shipbuilding yard infrastructure with floating dock (floating out) / fixed dry dock / any other suitable technology for the proposed location and also set up Ship repair maintenance facility.
- (vii) To assess the setting up of viable International size Ship yard.
- (viii) Consultant has to analysis if dredging required for slipway of ships and indicate the in the drawing in details.
- (ix) Consultant to suggest technical criteria like sizes of ships to be built, size and number of dry docks, berthing area, layout of shipyard, equipment's required.
- (x) Consultant has to be carryout all survey such as Geo-technical Investigation, Hydraulic, Geological, Hydrographic etc. for design of various Infrastructure development area.
- (xi) The detailed layout drawing of slipway facility and other various facilities like revetment / Bank protection work, ship lifting facility, winches, equipment to handle ship and its parts, ship repair yard, painting area, work shop, store, hard stand, office building, internal road, water supply, firefighting, electricity etc.
- (xii) Design of docks, berths and other structures proposed.
- (xiii) Detailed layout plan, Engineering Design & drawings, preparing specifications, bill of quantities, cost estimates with basis & justification

of rates.

- (xiv) Estimated cost of development should be realistic and based on local schedule of rates / market rate and their basis / documentary proof should be included in the DPR with necessary details.
- (xv) Ascertain types and sizes of ships to be handled at the shipbuilding yard and repair facility, time frame, handling methods, constraints, etc.
- (xvi) Suggest indicative rates, the O & M operator of the Slipway should charge for undertaking various repair works at the Slipway.
- (xvii) Preparation of contract / tender document for selecting O&M operator of shipbuilding yard and repair facility through an open tender.

- (xix) Consultant has to be indicated in the layout drawing all the facilities locate such as plate stock area, cutting area, fabrication area, unit assembly area, sub assembly area, grand assembly area, outlifting area, paint shelter and docks etc.

c) Design of Berth Structures

Detailed Design of berth structures including piles and super structure, tentative reinforcement details, founding levels and preparation of connected drawings (longitudinal and cross sections) for all the elements of the berthing & marine structure. The engineering shall also include provision of bollards, fenders, ladders etc. for smooth berthing operations.

d) Design of Dredging and Reclamation

Fixation of keel clearances for design vessels, depths of dredging in approach channel, turning circle, berth areas, & all maneuvering areas, computation of dredging & reclamation quantities with supporting calculations, dredging methods, details of reclamation / dumping grounds by matching the dredged quantity with reclamation quantity for economic optimization etc. Design of reclamation areas for the superimposed loads meeting the design and performance criteria. Sourcing of reclamation materials, if there is shortfall vis -a -vis dredged quantity may be indicated.

e) Design of Operational areas, Container Yard

Detailed Design of Operational areas, Container Yard, design of terminal pavements, and foundation for equipment and buildings, receipt and delivery areas.

f) Design of Utilities

Detailed Design including general arrangements and typical cross sections of all internal roads, water supply (including quantity and source), sewerage,



rainwater drainage system, landscaping, lighting, firefighting, IT and communications.

g) Design of Port Buildings

Design & Detailed Engineering of the Admin building, Security building, pump house, firefighting, substation, workshop, canteen & store, STP and others including Parking areas, In & Out Gates etc.

h) Specifications of Mechanization Equipment

Detailed specifications of cargo (containers / dry bulk / breakbulk) handling equipment at berth and Container yard shall be prepared to enable procurement.

i) Specifications of Port Crafts

The consultant shall assess the requirements of Port crafts required for the project to perform the various marine related activities over the development and operational phases of the port and prepare detailed specifications for the purpose of procurement.

j) Design of Electrical Distribution System

The consultant shall assess the requirements of Mechanical and Electrical Works, supply of power, identification of source & carry out detailed engineering of electrical works and furnish drawing based on the demand load. Emphasis to be given on renewable energy.

The debt equity structure along with sensitivity analysis may be carried out along with Economic IRR for the project.

### **8. Socio-Economic Assessment**

The Consultant shall have proper co-ordination & consultation with the NGOs / Social Agencies engaged for community outreach at field level with regard to project interventions and devise the infrastructure in complete satisfaction of the local communities.

Accordingly, the Consultant shall assess the following:

- i. Direct employment during construction and post construction.
- ii. Potential economic development and increase in employment opportunities in the region / hinterland of project.
- iii. The economic potential of the region shall be assessed. Economic Performance Index (EPI) shall be assessed and provided along with effect of development on EPI; and
- iv. Potential social effects include consideration of health, demographic, employment and generated wealth on account of the potential traffic.

## **9. Execution Plans & Implementation Schedule**

The consultant shall prepare phase-wise execution plans. The implementation schedule in phases shall also be prepared in the form of bar chart & PERT, CPM.

## **10. Preparation of DPR**

The consultant shall assess the available data & prepare a detailed project report. The scope shall include but not limited to the following.

- i. Review of previously collected data i.e., meteorological, oceanographic, seismic, etc.
- ii. Phase-wise execution of the project starting from the year 2026
- iii. Vessel temporal / trend Analysis, Percentage share of vessels & average parcel sizes, number of ships calls, storage areas for various cargo etc.

The consultant shall prepare a procurement strategy to decide the number of contract packages. For each contract package, the consultant shall prepare tender documents either on EPC basis, HAM model, PPP model etc.

## **11. Tendering Process up to selection of Contractor(s)**

- i. Recommendation of agencies with necessary credentials who can undertake the execution of each of the packages furnishing list of recommended / shortlisted contractors / agencies suitable for executing the work(s).
- ii. Consultant shall participate in pre-bid meeting to assist the Authority along with the bidders for the various packages and shall respond to queries of the bidders through Authority.
- iii. The Consultant shall carryout detail technical and financial review of bids which will include, scrutiny of various technical documents like DBR, preliminary engineering / design calculations and drawings, general design aspects, performance guarantees and QAP of various equipment of these systems, general arrangements, drawings etc and project planning and scheduling documents submitted by bidders with their bids to ensure that the bids are in conformity with tender specifications and with prevailing engineering practices adopted for such facilities
- iv. Consultant shall carryout a diligent scrutiny of the technical evaluation of the technical bids received for the packages, prepare list of clarifications required from the bidders, hold technical discussions with the bidders if required, and submit a technical evaluation report for facilitating the selection of the bidders by the Authority.

## **1. GENERAL**

### **1.1. Definitions and Interpretation**

1.1.1. The words and expressions beginning with capital letters and defined in this Agreement shall, unless the context otherwise requires, have the meaning hereinafter respectively assigned to them:

- (a) “Agreement” means this Agreement, together with all the Annexes;
- (b) “Agreement Value” shall have the meaning set forth in Clause 6.1;
- (c) “Applicable Laws” means the laws and any other instruments having the force of law in India as they may be issued and in force from time to time;
- (d) “Confidential Information” shall have the meaning set forth in Clause 5;
- (e) “Conflict of Interest” shall have the meaning set forth in Clause 5 read with the provisions of RFP;
- (f) “Dispute” shall have the meaning set forth in Clause 20;
- (g) “Effective Date” means the date on which this Agreement comes into force and effect pursuant to Clause 2.1;
- (h) “Expatriate Personnel” means such persons who at the time of being so hired had their domicile outside India;
- (i) “Government” means the Government of India;
- (j) “INR, Re. or Rs.” means Indian Rupees;
- (k) “Member”, in case the Consultant consists of a joint venture or consortium of more than one entity, means any of these entities, and “Members” means all of these entities;
- (l) “Party” means the Authority or the Consultant, as the case may be, and

Parties means both of them;

- (m) "Personnel" means persons hired by the Consultant or by any Sub-Consultant as employees and assigned to the performance of the Services or any part thereof;
- (n) "Resident Personnel" means such persons who at the time of being so hired had their domicile inside India;
- (o) "RFP" means the Request for Proposal document in response to which the Consultant's proposal for providing Services was accepted;
- (p) "Services" means the work to be performed by the Consultant pursuant to this Agreement, as described in the Terms of Reference hereto;
- (q) "Sub-Consultant" means any entity to which the Consultant subcontracts any part of the Services in accordance with the provisions of Clause 15;
- (r) "Third Party" means any person or entity other than the Government, the Authority, the Consultant or a Sub-Consultant.

All terms and words not defined herein shall, unless the context otherwise

---

requires, have the meaning assigned to them in the RFP.

- 1.1.2. The following documents along with all addenda issued thereto shall be deemed to form and be read and construed as integral parts of this Agreement and in case of any contradiction between or among them the priority in which a document would prevail over another would be as laid down below beginning from the highest priority to the lowest priority:

- (a) Agreement;
- (b) Annexes of Agreement;
- (c) RFP; and
- (d) Letter of Award.

## **1.2. Relation between the Parties**

Nothing contained herein shall be construed as establishing a relation of master and servant or of agent and principal as between the Authority and the Consultant. The Consultant shall, subject to this Agreement, have complete charge of Personnel performing the Services and shall be fully responsible for the Services performed by them or on their behalf hereunder.

## **1.3. Rights and obligations**

The mutual rights and obligations of the Authority and the Consultant shall

be as set forth in the Agreement, in particular:

- (a) the Consultant shall carry out the Services in accordance with the provisions of the Agreement; and
- (b) the Authority shall make payments to the Consultant in accordance with the provisions of the Agreement.

#### **1.4. Governing law and jurisdiction**

This Agreement shall be construed and interpreted in accordance with and governed by the laws of India, and the courts at Tuticorin shall have exclusive jurisdiction over matters arising out of or relating to this Agreement.

#### **1.5. Language**

All notices required to be given by one Party to the other Party and all other communications, documentation and proceedings which are in any way relevant to this Agreement shall be in writing and in English language.

#### **1.6. Table of contents and headings**

The table of contents, headings or sub-headings in this Agreement are for convenience of reference only and shall not be used in, and shall not affect, the construction or interpretation of this Agreement.

#### **1.7. Notices**

Any notice or other communication to be given by any Party to the other Party under or in connection with the matters contemplated by this Agreement shall be in writing and shall:

- (a) in the case of the Consultant, be given by facsimile or e-mail and by letter delivered by hand to the address given and marked for attention of the Consultant's Representative set out below in Clause 1.10 or to such other person as the Consultant may from time to time designate by notice to the Authority; provided that notices or other communications to be given to an address outside India may, if they are subsequently confirmed by sending a copy thereof by registered acknowledgement due, air mail or by courier, be sent by facsimile or e-mail to the number as the Consultant may from time to time designate by notice to the Authority;
- (b) in the case of the Authority, be given by facsimile or e-mail and by letter delivered by hand and be addressed to the Authority with a copy delivered to the Authority Representative set out below in Clause 1.10 or to such other person as the Authority may from time to time



designate by notice to the Consultant; provided that if the Consultant does not have an office in Mumbai/Navi Mumbai it may send such notice by facsimile or e-mail and by registered acknowledgement due, air mail or by courier; and

(c) any notice or communication by a Party to the other Party, given in accordance herewith, shall be deemed to have been delivered when in the normal course of post it ought to have been delivered and in all other cases, it shall be deemed to have been delivered on the actual date and time of delivery; provided that in the case of facsimile or e-mail, it shall be deemed to have been delivered on the working days following the date of its delivery.

#### **1.8. Location**

The Services shall be performed at the site of the Project in accordance with the provisions of RFP and at such locations as are incidental thereto, including the offices of the Consultant.

#### **1.9. Authority of Member-in-charge**

In case the Consultant consists of a consortium of more than one entity, the Parties agree that the Lead Member shall act on behalf of the Members in exercising all the Consultant's rights and obligations towards the Authority under this Agreement, including without limitation the receiving of instructions and payments from the Authority.

#### **1.10. Authorized Representatives**

1.10.1. Any action required or permitted to be taken, and any document required or permitted to be executed, under this Agreement by the Authority or the Consultant, as the case may be, may be taken or executed by the officials specified in this Clause 1.10.

1.10.2. The Authority may, from time to time, designate one of its officials as the Authority Representative. Unless otherwise notified, the Authority Representative shall be:

1.10.3. The Consultant may designate one of its employees as Consultant's Representative. Unless otherwise notified, the Consultant's Representative shall be:

#### **1.11. Taxes and duties**

Unless otherwise specified in the Agreement, the Consultant shall pay all such taxes, duties, fees and other impositions as may be levied under the Applicable Laws and the Authority shall perform such duties in regard to the deduction of such taxes as may be lawfully imposed on it.

### **2. COMMENCEMENT, COMPLETION AND TERMINATION OF AGREEMENT**

#### **2.1 Effectiveness of Agreement**

This Agreement shall come into force and effect on the date of this Agreement (the “**Effective Date**”).

#### **2.2. Commencement of Services**

The Consultant shall commence the Services within a period of 7 (seven) days from the Effective Date, unless otherwise agreed by the Parties.

#### **2.3. Termination of Agreement for failure to commence Services**

If the Consultant does not commence the Services within the period specified in Clause 2.2 above, the Authority may, by not less than 2 (two) weeks’ notice to the Consultant, declare this Agreement to be null and void, and in the event of such a declaration, the Bid Security of the Consultant shall stand forfeited.

#### **2.4. Expiration of Agreement**

Unless terminated earlier pursuant to Clauses 2.3 or 2.9 hereof, this Agreement shall, unless extended by the Parties by mutual consent, expire upon the expiry of contract period as mentioned in clause 2.1 V of Section 2 of Tender. Upon Termination, the Authority shall make payments of all amounts due to the Consultant hereunder.

#### **2.5. Entire Agreement**

- 2.5.1. This Agreement and the Annexes together constitute a complete and exclusive statement of the terms of the agreement between the Parties on the subject hereof, and no amendment or modification hereto shall be valid and effective unless such modification or amendment is agreed to in writing by the Parties and duly executed by persons especially empowered in this behalf by the respective Parties. All prior written or oral understandings, offers or other communications of every kind pertaining to

this Agreement are abrogated and withdrawn; provided, however, that the obligations of the Consultant arising out of the provisions of the RFP shall continue to subsist and shall be deemed to form part of this Agreement.

- 2.5.2. Without prejudice to the generality of the provisions of Clause 2.5.1, on matters not covered by this Agreement, the provisions of RFP shall apply.

## **2.6. Modification of Agreement**

Modification of the terms and conditions of this Agreement, including any modification of the scope of the Services, may only be made by written agreement between the Parties. Pursuant to Clauses 4.2.3 and 6.1.3 hereof, however, each Party shall give due consideration to any proposals for modification made by the other Party.

## **2.7. Force Majeure**

### **2.7.1. Definition**

- (a) For the purposes of this Agreement, "Force Majeure" means an event which is beyond the reasonable control of a Party, and which makes a Party's performance of its obligations hereunder impossible or so impractical as reasonably to be considered impossible in the circumstances, and includes, but is not limited to, war, riots, civil disorder, earthquake, epidemic/pandemic, fire, explosion, storm, flood or other adverse weather conditions, strikes, lockouts or other industrial action (except where such strikes, lockouts or other industrial action are within the power of the Party invoking Force Majeure to prevent), confiscation or any other action by government agencies.
- (b) Force Majeure shall not include (i) any event which is caused by the negligence or intentional action of a Party or such Party's Sub-Consultant or agents or employees, nor (ii) any event which a diligent Party could reasonably have been expected to both
  - (A) take into account at the time of the conclusion of this Agreement, and
  - (B) avoid or overcome in the carrying out of its obligations hereunder.
- (c) Force Majeure shall not include insufficiency of funds or failure to make any payment required hereunder.

### **2.7.2. No breach of Agreement**

The failure of a Party to fulfil any of its obligations hereunder shall not be considered to be a breach of, or default under, this Agreement insofar as such inability arises from an event of Force Majeure, provided that the Party affected by such an event has taken all reasonable precautions, due care and reasonable alternative measures, all with the objective of

carrying out the terms and conditions of this Agreement.

**2.7.3. Measures to be taken**

- (a) A Party affected by an event of Force Majeure shall take all reasonable measures to remove such Party's inability to fulfil its obligations hereunder with a minimum of delay.
- (b) A Party affected by an event of Force Majeure shall notify the other Party of such event as soon as possible, and in any event not later than 14 (fourteen) days following the occurrence of such event, providing evidence of the nature and cause of such event, and shall similarly give notice of the restoration of normal conditions as soon as possible.
- (c) The Parties shall take all reasonable measures to minimize the consequences of any event of Force Majeure.

**2.7.4. Extension of time**

Any period within which a Party shall, pursuant to this Agreement, complete any action or task, shall be extended for a period equal to the time during which such Party was unable to perform such action as a result of Force Majeure.

**2.7.5. Payments**

During the period of its inability to perform the Services as a result of an event of Force Majeure, the Consultant shall be entitled to be reimbursed for additional costs reasonably and necessarily incurred by it during such period for the purposes of the Services and in reactivating the Services after the end of such period.

**2.7.6. Consultation**

Not later than 30 (thirty) days after the Consultant has, as the result of an event of Force Majeure, become unable to perform a material portion of the Services, the Parties shall consult with each other with a view to agreeing on appropriate measures to be taken in the circumstances.

**2.8. Suspension of Agreement**

The Authority may, by written notice of suspension to the Consultant, suspend all payments to the Consultant hereunder if the Consultant shall be in breach of this Agreement or shall fail to perform any of its obligations under this Agreement, including the carrying out of the Services; provided that such notice of suspension (i) shall specify

the nature of the breach or failure, and (ii) shall provide an opportunity to

the Consultant to remedy such breach or failure within a period not exceeding 30 (thirty) days after receipt by the Consultant of such notice of suspension.

## **2.9. Termination of Agreement**

### **2.9.1. By the Authority**

The Authority may, by not less than 30 (thirty) days' written notice of termination to the Consultant, such notice to be given after the occurrence of any of the events specified in this Clause 2.9.1, terminate this Agreement if:

- (a) the Consultant fails to remedy any breach hereof or any failure in the performance of its obligations hereunder, as specified in a notice of suspension pursuant to Clause 2.8 hereinabove, within 30 (thirty) days of receipt of such notice of suspension or within such further period as the Authority may have subsequently granted in writing;
- (b) the Consultant becomes insolvent or bankrupt or enters into any agreement with its creditors for relief of debt or take advantage of any law for the benefit of debtors or goes into liquidation or receivership whether compulsory or voluntary;
- (c) the Consultant fails to comply with any final decision reached as a result of arbitration proceedings pursuant to Clause 20.4 hereof;
- (d) the Consultant submits to the Authority a statement which has a material effect on the rights, obligations or interests of the Authority and which the Consultant knows to be false;
- (e) any document, information, data or statement submitted by the Consultant in its Proposals, based on which the Consultant was considered eligible or successful, is found to be false, incorrect or misleading;
- (f) as the result of Force Majeure, the Consultant is unable to perform a material portion of the Services for a period of not less than 60 (sixty) days; or
- (g) the Authority, in its sole discretion and for any reason whatsoever, decides to terminate this Agreement.

### **2.9.2. By the Consultant**

The Consultant may, by not less than 30 (thirty) days' written notice to the Authority, such notice to be given after the occurrence of any of the events

specified in this Clause 2.9.2, terminate this Agreement if:

- (a) the Authority fails to pay any money due to the Consultant pursuant to this Agreement and not subject to dispute pursuant to Clause 20 hereof within 45 (forty five) days after receiving written notice from the Consultant that such payment is overdue;
- (b) the Authority is in material breach of its obligations pursuant to this Agreement and has not remedied the same within 45 (forty five) days (or such longer period as the Consultant may have subsequently granted in writing) following the receipt by the Authority of the Consultant's notice specifying such breach;
- (c) as the result of Force Majeure, the Consultant is unable to perform a material portion of the Services for a period of not less than 60 (sixty) days; or
- (d) the Authority fails to comply with any final decision reached as a result of arbitration pursuant to Clause 20.4 hereof.

#### **2.9.3. Cessation of rights and obligations**

Upon termination of this Agreement pursuant to Clauses 2.3 or 2.9 hereof, or upon expiration of this Agreement pursuant to Clause 2.4 hereof, all rights and obligations of the Parties hereunder shall cease, except (i) such rights and obligations as may have accrued on the date of termination or expiration, or which expressly survive such Termination; (ii) the obligation of confidentiality set forth in Clause 5 hereof; (iii) the Consultant's obligation to permit inspection, copying and auditing of such of its accounts and records set forth in Clause 8, as relate to the Consultant's Services provided under this Agreement; and (iv) any right or remedy which a Party may have under this Agreement or the Applicable Law.

#### **2.9.4. Cessation of Services**

Upon termination of this Agreement by notice of either Party to the other pursuant to Clauses 2.9.1 or 2.9.2 hereof, the Consultant shall, immediately upon dispatch or receipt of such notice, take all necessary steps to bring the Services to a close in a prompt and orderly manner and shall make every reasonable effort to keep expenditures for this purpose to a minimum. With respect to documents prepared by the Consultant and equipment and materials furnished by the Authority, the Consultant shall proceed as provided respectively by Clauses 11 or 12 hereof.

#### **2.9.5. Payment upon Termination**

Upon termination of this Agreement pursuant to Clauses 2.9.1 or 2.9.2

hereof, the Authority shall make the following payments to the Consultant (after offsetting against these payments any amount that may be due from the Consultant to the Authority):

- i) remuneration pursuant to Clause 17 hereof for Services satisfactorily performed prior to the date of termination;
- ii) reimbursable expenditures pursuant to Clause 17 hereof for expenditures actually incurred prior to the date of termination; and
- iii) except in the case of termination pursuant to sub-clauses (a) through (e) of Clause 2.9.1 hereof, reimbursement of any reasonable cost incidental to the prompt and orderly termination of the Agreement including the cost of the return travel of the Consultant's personnel.

#### **2.9.6. Disputes about Events of Termination**

If either Party disputes whether an event specified in Clause 2.9.1 or in Clause 2.9.2 hereof has occurred, such Party may, within 30 (thirty) days after receipt of notice of termination from the other Party, refer the matter to arbitration pursuant to Clause 20.4 hereof, and this Agreement shall not be terminated on account of such event except in accordance with the terms of any resulting arbitral award.

### **3. OBLIGATIONS OF THE CONSULTANT**

#### **3.1. General**

##### **3.1.1. Standards of Performance**

The Consultant shall perform the Services and carry out its obligations hereunder with all due diligence, efficiency and economy, in accordance with generally accepted professional techniques and practices, and shall observe sound management practices, and employ appropriate advanced technology and safe and effective equipment, machinery, materials and methods. The Consultant shall always act, in respect of any matter relating to this Agreement or to the Services, as a faithful adviser to the Authority, and shall at all times support and safeguard the Authority's legitimate interests in any dealings with Sub-Consultants or Third Parties.

##### **3.1.2. Terms of Reference**

The scope of services to be performed by the Consultant is specified in the Terms of Reference (the "TOR") at Annex-1 of this Agreement. The Consultant shall provide the Deliverables specified therein in conformity with the time schedule stated therein.

### **3.1.3. Applicable Laws**

The Consultant shall perform the Services in accordance with the Applicable Laws and shall take all practicable steps to ensure that any Sub-Consultant, as well as the Personnel and agents of the Consultant and any Sub- Consultant, comply with the Applicable Laws.

## **4. Conflict of Interest**

4.1. The Consultant shall not have a Conflict of Interest and any breach hereof shall constitute a breach of the Agreement.

4.2. Consultant and Affiliates not to be otherwise interested in the Project

The Consultant agrees that, during the term of this Agreement and after its termination, the Consultant or any Associate thereof and any entity affiliated with the Consultant, as well as any Sub-Consultant and any entity affiliated with such Sub-Consultant, shall be disqualified from providing goods, works, services, loans or equity for any project resulting from or closely related to the Services and any breach of this obligation shall amount to a Conflict of Interest; provided that the restriction herein shall not apply after a period of five years from the completion of this assignment or to consulting assignments granted by banks/ lenders at any time; provided further that this restriction shall not apply to consultancy/ advisory services provided to the Authority in continuation of this Consultancy or to any subsequent consultancy/ advisory services provided to the Authority in accordance with the rules of the Authority. For the avoidance of doubt, an entity affiliated with the Consultant shall include a partner in the Consultant's firm or a person who holds more than 5% (five per cent) of the subscribed and paid up share capital of the Consultant, as the case may be, and any Associate thereof.

## **4.3. Prohibition of conflicting activities**

Neither the Consultant nor its Sub-Consultant nor the Personnel of either of them shall engage, either directly or indirectly, in any of the following activities:

- (a) during the term of this Agreement, any business or professional activities which would conflict with the activities assigned to them under this Agreement;
- (b) after the termination of this Agreement, such other activities as may be specified in the Agreement; or
- (c) at any time, such other activities as have been specified in the RFP as



## Conflict of Interest.

### **4.4. Consultant not to benefit from commissions, discounts, etc.**

The remuneration of the Consultant pursuant to Clause 6 hereof shall constitute the Consultant's sole remuneration in connection with this Agreement or the Services and the Consultant shall not accept for its own benefit any trade commission, discount or similar payment in connection with activities pursuant to this Agreement or to the Services or in the discharge of its obligations hereunder, and the Consultant shall use its best efforts to ensure that any Sub-Consultant, as well as the Personnel and agents of either of them, similarly shall not receive any such additional remuneration.

- 4.5. The Consultant and its Personnel shall observe the highest standards of ethics and shall not have engaged in and shall not hereafter engage in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice (collectively the "Prohibited Practices"). Notwithstanding anything to the contrary contained in this Agreement, the Authority shall be entitled to terminate this Agreement forthwith by a communication in writing to the Consultant, without being liable in any manner whatsoever to the Consultant, if it determines that the Consultant has, directly or indirectly or through an agent, engaged in any Prohibited Practices in the Selection Process or before or after entering into of this Agreement. In such an event, the Authority shall forfeit and appropriate the performance security, if any, as mutually agreed genuine pre-estimated compensation and damages payable to the Authority towards, inter alia, the time, cost and effort of the Authority, without prejudice to the Authority's any other rights or remedy hereunder or in law.
- 4.6. Without prejudice to the rights of the Authority and the other rights and remedies which the Authority may have under this Agreement, if the Consultant is found by the Authority to have directly or indirectly or through an agent, engaged or indulged in any Prohibited Practices, during the Selection Process or before or after the execution of this Agreement, the Consultant shall not be eligible to participate in any RFP or RFP issued during a period of 2 (two) years from the date the Consultant is found by the Authority to have directly or indirectly or through an agent, engaged or indulged in any Prohibited Practices.
- 4.7. For the purposes of Clauses 14.5 and 14.6, the following terms shall have the meaning hereinafter respectively assigned to them:
- (a) "corrupt practice" means the offering, giving, receiving or soliciting, directly or indirectly, of anything of value to influence the actions of any

person connected with the Selection Process (for removal of doubt, offering of employment or employing or engaging in any manner whatsoever, directly or indirectly, any official of the Authority who is or has been associated in any manner, directly or indirectly with Selection Process or LOA or dealing with matters concerning the Agreement before or after the execution thereof, at any time prior to the expiry of one year from the date such official resigns or retires from or otherwise ceases to be in the service of the Authority, shall be deemed to constitute influencing the actions of a person connected with the Selection Process); or (ii) engaging in any manner whatsoever, whether during the Selection Process or after the issue of LOA or after the execution of the Agreement, as the case may be, any person in respect of any matter relating to the Project or the LOA or the Agreement, who at any time has been or is a legal, financial or technical adviser the Authority in relation to any matter concerning the Project;

- (b) “fraudulent practice” means a misrepresentation or omission of facts or suppression of facts or disclosure of incomplete facts, in order to influence the Selection Process;
- (c) “coercive practice” means impairing or harming, or threatening to impair or harm, directly or indirectly, any person or property to influence any person’s participation or action in the Selection Process or the exercise of its rights or performance of its obligations by the Authority under this Agreement;
- (d) “undesirable practice” means (i) establishing contact with any person connected with or employed or engaged by the Authority with the objective of canvassing, lobbying or in any manner influencing or attempting to influence the Selection Process; or (ii) having a Conflict of Interest; and
- (e) “restrictive practice” means forming a cartel or arriving at any understanding or arrangement among Applicants with the objective of restricting or manipulating a full and fair competition in the Selection Process.

## **5. Confidentiality**

The Consultant, its Sub-Consultants and the Personnel of either of them shall not, either during the term or within two years after the expiration or termination of this Agreement disclose any proprietary information, including information relating to reports, data, drawings, design software or other material, whether written or oral, in electronic or magnetic format, and the contents thereof; and any reports, digests or summaries created

or derived from any of the foregoing that is provided by the Authority to the Consultant, its Sub-Consultants and the Personnel; any information provided by or relating to the Authority, its technology, technical processes, business affairs or finances or any information relating to the Authority's employees, officers or other professionals or suppliers, customers, or contractors of the Authority; and any other information which the Consultant is under an obligation to keep confidential in relation to the Project, the Services or this Agreement ("Confidential Information"), without the prior written consent of the Authority. Notwithstanding the aforesaid, the Consultant, its Sub-Consultants and the Personnel of either of them may disclose Confidential Information to the extent that such Confidential Information:

- i) was in the public domain prior to its delivery to the Consultant, its Sub-Consultants and the Personnel of either of them or becomes a part of the public knowledge from a source other than the Consultant, its Sub-Consultants and the Personnel of either of them;
- ii) was obtained from a third party with no known duty to maintain its confidentiality;
- iii) is required to be disclosed by Applicable Laws or judicial or administrative or arbitral process or by any governmental instrumentalities, provided that for any such disclosure, the Consultant, its Sub-Consultants and the Personnel of either of them shall give the Authority, prompt written notice, and use reasonable efforts to ensure that such disclosure is accorded confidential treatment; and
- iv) is provided to the professional advisers, agents, auditors or representatives of the Consultant or its Sub-Consultants or Personnel of either of them, as is reasonable under the circumstances; provided, however, that the Consultant or its Sub-Consultants or Personnel of either of them, as the case may be, shall require their professional advisers, agents, auditors or its representatives, to undertake in writing to keep such Confidential Information, confidential and shall use its best efforts to ensure compliance with such undertaking.

## **6. Liability of the Consultant**

- 6.1. The Consultant's liability under this Agreement shall be determined by the Applicable Laws and the provisions hereof.
- 6.2. Consultant's liability towards the Authority

The Consultant shall, subject to the limitation specified in Clause 3.4.3, be liable to the Authority for any direct loss or damage accrued or likely to

accrue due to deficiency in Services rendered by it.

- 6.3. The Parties hereto agree that in case of negligence or wilful misconduct on the part of the Consultant or on the part of any person or firm acting on behalf of the Consultant in carrying out the Services, the Consultant, with respect to damage caused to the Authority's property, shall not be liable to the Authority:
- i) for any indirect or consequential loss or damage; and
  - (ii) for any direct loss or damage upto the agreement value of the contract.
- 6.4. This limitation of liability specified in Clause 3.4.3 shall not affect the Consultant's liability, if any, for damage to Third Parties caused by the Consultant or any person or firm acting on behalf of the Consultant in carrying out the Services subject, however, to a limit equal to 3 (three) times the Agreement Value.

## **7. Insurance to be taken out by the Consultant**

- 7.1. The Consultant shall, for the duration of this Agreement, take out and maintain, and shall cause any Sub-Consultant to take out and maintain, at its (or the Sub-Consultant's, as the case may be) own cost, but on terms and conditions approved by the Authority, insurance against the risks, and for the coverages, as specified in the Agreement and in accordance with good industry practice.
- (a) Within 15 (fifteen) days of receiving any insurance policy certificate in respect of insurances required to be obtained and maintained under this clause, the Consultant shall furnish to the Authority, copies of such policy certificates, copies of the insurance policies and evidence that the insurance premium have been paid in respect of such insurance. No insurance shall be cancelled, modified or allowed to expire or lapse during the term of this Agreement.
  - (b) If the Consultant fails to effect and keep in force the aforesaid insurances for which it is responsible pursuant hereto, the Authority shall, apart from having other recourse available under this Agreement, have the option, without prejudice to the obligations of the Consultant, to take out the aforesaid insurance, to keep in force any such insurances, and pay such premium and recover the costs thereof from the Consultant, and the Consultant shall be liable to pay such amounts on demand by the Authority.
  - (c) Except in case of Third Party liabilities, the insurance policies so procured shall mention the Authority as the beneficiary of the Consultant and the Consultant shall procure an undertaking from the

insurance company to this effect; provided that in the event the Consultant has a general insurance policy that covers the risks specified in this Agreement and the amount of insurance cover is equivalent to 3 (three) times the cover required hereunder, such insurance policy may not mention the Authority as the sole beneficiary of the Consultant or require an undertaking to that effect.

7.2. The Parties agree that the risks and coverage's shall include but not be limited to the following:

- (a) Third Party liability insurance as required under Applicable Laws, with a minimum coverage of not less than the agreement value of the contract;
- (b) employer's liability and workers' compensation insurance in respect of the Personnel of the Consultant and of any Sub-Consultant, in accordance with Applicable Laws; and
- (c) Professional liability insurance for an amount no less than the Agreement Value.

The indemnity limit in terms of "Any One Accident" (AOA) and "Aggregate limit on the policy period" (AOP) should not be less than the amount stated in Clause 6.1.2 of the Agreement. In case of consortium, the policy should be in the name of Lead Member and not in the name of individual Members of the consortium.

## **8. Accounting, inspection and auditing**

The Consultant shall:

- (a) keep accurate and systematic accounts and records in respect of the Services provided under this Agreement, in accordance with internationally accepted accounting principles and in such form and detail as will clearly identify all relevant time charges and cost, and the basis thereof (including the basis of the Consultant's costs and charges); and
- (b) permit the Authority or its designated representative periodically, and up to one year from the expiration or termination of this Agreement, to inspect the same and make copies thereof as well as to have them audited by auditors appointed by the Authority.

## **9. Consultant's actions requiring the Authority's prior approval**

The Consultant shall obtain the Authority's prior approval in writing before

taking any of the following actions:

- (a) Appointing such members of the Professional Personnel as are not listed in Annex-2.
- (b) entering into a subcontract for the performance of any part of the Services, it being understood (i) that the selection of the Sub-Consultant and the terms and conditions of the subcontract shall have been approved in writing by the Authority prior to the execution of the subcontract, and (ii) that the Consultant shall remain fully liable for the performance of the Services by the Sub-Consultant and its Personnel pursuant to this Agreement; or
- (c) Any other action that is specified in this Agreement.

## **10. Reporting obligations**

The Consultant shall submit to the Authority the reports specified in the Agreement, in the form, in the numbers and within the time periods set forth therein.

## **11. Documents prepared by the Consultant to be property of the Authority**

- 11.1. All plans, drawings, specifications, designs, reports and other documents (collectively referred to as "Consultancy Documents") prepared by the Consultant (or by the Sub-Consultants or any Third Party) in performing the Services shall become and remain the property of the Authority, and all intellectual property rights in such Consultancy Documents shall vest with the Authority. Any Consultancy Document, of which the ownership or the intellectual property rights do not vest with the Authority under law, shall automatically stand assigned to the Authority as and when such Consultancy Document is created and the Consultant agrees to execute all papers and to perform such other acts as the Authority may deem necessary to secure its rights herein assigned by the Consultant.
- 11.2. The Consultant shall, not later than termination or expiration of this Agreement, deliver all Consultancy Documents to the Authority, together with a detailed inventory thereof. The Consultant may retain a copy of such Consultancy Documents. The Consultant, its Sub-Consultants or a Third Party shall not use these Consultancy Documents for purposes unrelated to this Agreement without the prior written approval of the Authority.
- 11.3. The Consultant shall hold the Authority harmless and indemnified for any losses, claims, damages, expenses (including all legal expenses),

awards, penalties or injuries (collectively referred to as 'claims') which may arise from or due to any unauthorized use of such Consultancy Documents, or due to any breach or failure on part of the Consultant or its Sub-Consultants or a Third Party to perform any of its duties or obligations in relation to securing the aforementioned rights of the Authority.

**12. Equipment and materials furnished by the Authority**

Equipment and materials made available to the Consultant by the Authority shall be the property of the Authority and shall be marked accordingly. Upon termination or expiration of this Agreement, the Consultant shall furnish forthwith to the Authority, an inventory of such equipment and materials and shall dispose of such equipment and materials in accordance with the instructions of the Authority. While in possession of such equipment and materials, the Consultant shall, unless otherwise instructed by the Authority in writing, insure them in an amount equal to their full replacement value.

**13. Providing access to Project Office and Personnel**

The Consultant shall ensure that the Authority, and officials of the Authority having authority from the Authority, are provided unrestricted access to the Project Office and to all Personnel during office hours. The Authority's official, who has been authorized by the Authority in this behalf, shall have the right to inspect the Services in progress, interact with Personnel of the Consultant and verify the records relating to the Services for his satisfaction.

**14. Accuracy of Documents**

The Consultant shall be responsible for accuracy of the data collected by it directly or procured from other agencies/authorities, the designs, drawings, estimates and all other details prepared by it as part of these services. Subject to the provisions of Clause 28, it shall indemnify the Authority against any inaccuracy in its work which might surface during implementation of the Project, if such inaccuracy is the result of any negligence or inadequate due diligence on part of the Consultant or arises out of its failure to conform to good industry practice. The Consultant shall also be responsible for promptly correcting, at its own cost and risk, the drawings including any re-survey / investigations.

**15. CONSULTANT'S PERSONNEL AND SUB-CONSULTANTS**

**15.1 General**

The Consultant shall employ and provide such qualified and experienced

Personnel as may be required to carry out the Services.

## **15.2 Deployment of Personnel**

- 15.2.1. The designations, names and the estimated periods of engagement in carrying out the Services by each of the Consultant's Personnel are described in Annex-2 of this Agreement.
- 15.2.2. Adjustments with respect to the estimated periods of engagement of Personnel set forth in the aforementioned **Annex-2** may be made by the Consultant by written notice to the Authority.
- 15.2.3. If additional work is required beyond the scope of the Services specified in the Terms of Reference, the estimated periods of engagement of Personnel, set forth in the Annexures of the Agreement may be increased by agreement in writing between the Authority and the Consultant, provided that any such increase shall not, except as otherwise agreed, cause payments under this Agreement to exceed the Agreement Value set forth in Clause 6.1.

## **15.3. Approval of Personnel**

- 15.3.1. The Professional Personnel listed in Annex-2 of the Agreement are hereby approved by the Authority. No other Professional Personnel shall be engaged without prior approval of the Authority.
- 15.3.2. If the Consultant hereafter proposes to engage any person as Professional Personnel, it shall submit to the Authority its proposal along with a CV of such person in the form provided at Appendix-I (Form-14) of the RFP. The Authority may approve or reject such proposal within 14 (fourteen) days of receipt thereof. In case the proposal is rejected, the Consultant may propose an alternative person for the Authority's consideration. In the event the Authority does not reject a proposal within 14 (fourteen) days of the date of receipt thereof under this Clause 15.3.2, it shall be deemed to have been approved by the Authority.

### **15.3.3. Substitution of Key Personnel**

The Authority expects all the Key Personnel specified in the Proposal to be available during implementation of the Agreement. The Authority will not consider any substitution of Key Personnel except under compelling circumstances beyond the control of the Consultant and the concerned Key Personnel. Such substitution shall be limited to not more than two Key Personnel subject to equally or better qualified and experienced personnel being provided to the satisfaction of the Authority. Without prejudice to the foregoing, substitution of one Key Personnel shall be permitted subject to reduction of remuneration equal to 2% (two per cent)



of the total remuneration specified for the Key Personnel who is proposed to be substituted. In case of a second substitution, such reduction shall be equal to 5% (five per cent) of the total remuneration specified for the Key Personnel who is proposed to be substituted.

#### **15.3.4. HOURS OF WORK / OVERTIME / LEAVE FOR KEY PERSONNEL**

Working hours of key personnel shall normally be 8 hours a day and six days a week. Hours of key personnel should broadly match with those of Client. However, the consultant has to complete the job in prescribed time frame and client shall not make any payment for any overtime except in case of work arising from clients variation orders.

The Personnel shall not be entitled to be paid for overtime nor to take paid sick leave or vacation leave except as specified in the Agreement, and the Consultant's remuneration shall be deemed to cover these items. All leave to be allowed to the Personnel is excluded from the man-days of service set forth in Annex-2. Any taking of leave by any Personnel for a period exceeding 7 (seven) days shall be subject to the prior approval of the Authority, and the Consultant shall ensure that any absence on leave will not delay the progress and quality of the Services.

#### **15.3.5. Resident Team Leader**

The person designated as the Team Leader of the Consultant's Personnel shall be responsible for the coordinated, timely and efficient functioning of the Personnel. In addition, the Consultant shall designate a suitable person as Project Manager (the "Project Manager") who shall be responsible for day to day performance of the Services.

#### **15.3.6. Sub-Consultants**

Sub-Consultants listed in Annex-4 of this Agreement are hereby approved by the Authority. The Consultant may, with prior written approval of the Authority, engage additional Sub-Consultants or substitute an existing Sub-Consultant. The hiring of Personnel by the Sub-Consultants shall be subject to the same conditions as applicable to Personnel of the Consultant under this Clause 15.3.6.

### **16. OBLIGATIONS OF THE AUTHORITY**

#### **16.1 Assistance in clearances etc.**

Unless otherwise specified in the Agreement, the Authority shall make best efforts to ensure that the Government shall:

(a) provide the Consultant, its Sub-Consultants and Personnel with work

- permits and such other documents as may be necessary to enable the Consultant, its Sub-Consultants or Personnel to perform the Services;
- (b) facilitate prompt clearance through customs of any property required for the Services; and issue to officials, agents and representatives of the Government all such instructions as may be necessary or appropriate for the prompt and effective implementation of the Services.

#### **16.2. Access to land and property**

The Authority warrants that the Consultant shall have, free of charge, unimpeded access to the site of the project in respect of which access is required for the performance of Services; provided that if such access shall not be made available to the Consultant as and when so required, the Parties shall agree on (i) the time extension, as may be appropriate, for the performance of Services, and (ii) the additional payments, if any, to be made to the Consultant as a result thereof pursuant to Clause 6.1.3.

#### **16.3 Change in Applicable Law**

If, after the date of this Agreement, there is any change in the Applicable Laws with respect to taxes and duties which increases or decreases the cost or reimbursable expenses incurred by the Consultant in performing the Services, by an amount exceeding 2% (two per cent) of the Agreement Value specified in Clause 6.2, then the remuneration and reimbursable expenses otherwise payable to the Consultant under this Agreement shall be increased or decreased accordingly by agreement between the Parties hereto, and corresponding adjustments shall be made to the aforesaid Agreement Value.

#### **16.4. Payment**

In consideration of the Services performed by the Consultant under this Agreement, the Authority shall make to the Consultant such payments and in such manner as is provided in Clause 17 of this Agreement.

### **17. PAYMENT TO THE CONSULTANT**

#### **17.1 Cost estimates**

The employer shall pay the consultant for normal services in accordance with the details stated in APPENDIX-II, form-2 of financial proposal at the end of for the part of work completed.

#### **17.2. Remuneration and reimbursable Expenditures**

It is understood that the fee quoted by consultant at Appendix-II, Form-2 covers for all and sundry. No extra payments, other than the quoted at

Appendix –II, Form– 2, or reimbursements shall be made to the consultant by the employer except as provided in the contract.

17.3 Currency of payment: All payments shall be made in Indian Rupees. The Consultant shall be free to convert Rupees into any foreign currency as per Applicable Laws.

17.4 (a) The Authority shall cause the payment due to the Consultant to be made within 30 (thirty) days after the receipt by the Authority of duly completed bills with necessary particulars (the “Due Date”).

(b) The final payment under this Clause shall be made as per the deliverables submitted by the Consultant and approved as satisfactory by the Authority. The Services shall be deemed completed and finally accepted by the Authority and the final deliverable shall be deemed approved by the Authority as satisfactory upon expiry of 90 (ninety) Schedule-2: Form of Agreement days after receipt of the final deliverable by the Authority unless the Authority, within such 90 (ninety) day period, gives written notice to the Consultant specifying in detail, the deficiencies in the Services. The Consultant shall thereupon promptly make any necessary corrections and / or additions, and upon completion of such corrections or additions, the foregoing process shall be repeated. The Authority shall make the final payment upon acceptance or deemed acceptance of the final deliverable by the Authority.

(c) Any amount which the Authority has paid or caused to be paid in excess of the amounts actually payable in accordance with the provisions of this Agreement shall be reimbursed by the Consultant to the Authority within 30 (thirty) days after receipt by the Consultant of notice thereof. Any such claim by the Authority for reimbursement must be made within 1 (one) year after receipt by the Authority of a final report in accordance with Clause 17.4 (b). Any delay by the Consultant in reimbursement by the due date shall attract simple interest @ 10% (ten per cent) per annum.

(d) All payments under this Agreement shall be made to the account of the Consultant as may be notified to the Authority by the Consultant.

## **18. LIQUIDATED DAMAGES AND PENALTIES**

### **18.1. Performance Security**

18.1.1. The Authority shall retain by way of performance security (the “Performance Security”), 5% (five per cent) of all the amounts due and payable to the Consultant, to be appropriated against breach of this Agreement or for recovery of liquidated damages as specified in Clause 18.2 herein. Further, A sum @ 10% of the gross amount of the bill shall be deducted from each Running Bill of the Contractor till the sum will

amount to Security Deposit of 5% of the tendered value of the work. Both Performance Security and Security Deposit shall be returned to the Consultant at the end of 3 (three) months after the expiration of the Agreement as per the T&C of the agreement. The balance remaining out of the Performance Security shall be returned to the Consultant at the end of 3 (three) months after the expiration of this Agreement pursuant to Clause 2.4 hereof.

- 18.1.2. The Consultant may, in lieu of retention of the amounts as referred to in Clause 18.1.1 above, furnish a Bank Guarantee substantially in the form specified at Annex-7 of this Agreement.

## **18.2. Liquidated Damages**

### **18.2.1. Liquidated Damages for error / variation**

In case any error or variation is detected in the reports submitted by the Consultant and such error or variation is the result of negligence or lack of due diligence on the part of the Consultant, the consequential damages thereof shall be quantified by the Authority in a reasonable manner and recovered from the Consultant by way of deemed liquidated damages, subject to a maximum of 5% (five per cent) of the Agreement Value.

### **18.2.2. Liquidated Damages for delay**

In case of delay in completion of Services, liquidated damages not exceeding an amount equal to 1% of the Agreement Value per week, subject to a maximum of 10% (ten percent) of the Agreement Value will be imposed and shall be recovered by appropriation from the Performance Security or otherwise. However, in case of delay due to reasons beyond the control of the Consultant, suitable extension of time shall be granted.

### **18.2.3. Encashment and appropriation of Performance Security**

The Authority shall have the right to invoke and appropriate the proceeds of the Performance Security, in whole or in part, without notice to the Consultant in the event of breach of this Agreement or for recovery of liquidated damages specified in this Clause 18.2.

## **18.3. Penalty for deficiency in Services**

In addition to the liquidated damages not amounting to penalty, as specified in Clause 18.2, warning may be issued to the Consultant for minor deficiencies on its part. In the case of significant deficiencies in Services causing adverse effect on the Project or on the reputation of the Authority, other penal action including debarring for a specified period may also be initiated as per policy of the Authority.

## **19. FAIRNESS AND GOOD FAITH**

### **19.1 Good Faith**

The Parties undertake to act in good faith with respect to each other's rights under this Agreement and to adopt all reasonable measures to ensure the realization of the objectives of this Agreement.

### **19.2. Operation of the Agreement**

The Parties recognize that it is impractical in this Agreement to provide for every contingency which may arise during the life of the Agreement, and the Parties hereby agree that it is their intention that this Agreement shall operate fairly as between them, and without detriment to the interest of either of them, and that, if during the term of this Agreement either Party believes that this Agreement is operating unfairly, the Parties will use their best efforts to agree on such action as may be necessary to remove the cause or causes of such unfairness, but failure to agree on any action pursuant to this Clause shall not give rise to a dispute subject to arbitration in accordance with Clause 20 hereof.

## **20. SETTLEMENT OF DISPUTES**

### **20.1 Amicable settlement**

The Parties shall use their best efforts to settle amicably all disputes arising out of or in connection with this Agreement or the interpretation thereof.

### **20.2. Dispute resolution**

20.2.1. Any dispute, difference or controversy of whatever nature howsoever arising under or out of or in relation to this Agreement (including its interpretation) between the Parties, and so notified in writing by either Party to the other Party (the "Dispute") shall, in the first instance, be attempted to be resolved amicably in accordance with the conciliation procedure set forth in Clause 20.3.

20.2.2. The Parties agree to use their best efforts for resolving all Disputes arising under or in respect of this Agreement promptly, equitably and in good faith, and further agree to provide each other with reasonable access during normal business hours to all non-privileged records, information and data pertaining to any Dispute.

### **20.3. Conciliation**

In the event of any Dispute between the Parties, either Party may call upon Chairman of VOC Port Authority, Tuticorin and the Chairman of the

Board of Directors of the Consultant or a substitute thereof for amicable settlement, and upon such reference, the said persons shall meet no later than 10 (ten) days from the date of reference to discuss and attempt to amicably resolve the Dispute. If such meeting does not take place within the 10 (ten) day period or the Dispute is not amicably settled within 15 (fifteen) days of the meeting or the Dispute is not resolved as evidenced by the signing of written terms of settlement within 30 (thirty) days of the notice in writing referred to in Clause 20 or such longer period as may be mutually agreed by the Parties, either Party may refer the Dispute to arbitration in accordance with the provisions of Clause 20.4.

#### **20.4. Arbitration**

- 20.4.1. Any Dispute which is not resolved amicably by conciliation, as provided in Clause 20.2.1, shall be finally decided by reference to arbitration by an Arbitral Tribunal appointed in accordance with Clause 20.4.2. Such arbitration shall be held in accordance with the Rules of Arbitration of the International Centre for Alternative Dispute Resolution, New Delhi (the "Rules"), or such other rules as may be mutually agreed by the Parties, and shall be subject to the provisions of the Arbitration and Conciliation Act, 1996. The venue of such arbitration shall be Tuticorin and the language of arbitration proceedings shall be English.
- 20.4.2. There shall be an Arbitral Tribunal of three arbitrators, of whom each Party shall select one, and the third arbitrator shall be appointed by the two arbitrators so selected, and in the event of disagreement between the two arbitrators, the appointment shall be made in accordance with the Rules.
- 20.4.3. The arbitrators shall make a reasoned award (the "Award"). Any Award made in any arbitration held pursuant to this Clause 20 shall be final and binding on the Parties as from the date it is made, and the Consultant and the Authority agree and undertake to carry out such Award without delay.
- 20.4.4. The Consultant and the Authority agree that an Award may be enforced against the Consultant and / or the Authority, as the case may be, and their respective assets wherever situated.
- 20.4.5. This Agreement and the rights and obligations of the Parties shall remain in full force and effect, pending the Award in any arbitration proceedings hereunder.

## **SCHEDULE-3**

### **Guidance Note on Conflict of Interest**

1. This Note further explains and illustrates the provisions of Clause 4 of the RFP and shall be read together therewith in dealing with specific cases.
2. Consultants should be deemed to be in a conflict-of-interest situation if it can be reasonably concluded that their position in a business or their personal interest could improperly influence their judgment in the exercise of their duties. The process for selection of consultants should avoid both actual and perceived conflict of interest.
3. Conflict of interest may arise between the Authority and a consultant or between consultants and present or future concessionaries / contractors.

Some of the situations that would involve conflict of interest are identified below:

(a) Authority and consultants:

- i) Potential consultant should not be privy to information from the Authority which is not available to others; or
- ii) potential consultant should not have defined the project when earlier working for the Authority; or
- iii) Potential consultant should not have recently worked for the Authority overseeing the project.

(b) Consultants and concessionaires / contractors:

- i) No consultant should have an ownership interest or a continuing business interest or an on-going relationship with a potential concessionaire/ contractor save and except relationships restricted to project-specific and short-term assignments; or
- ii) no consultant should be involved in owning or operating entities resulting from the project; or
- iii) no consultant should bid for works arising from the project.

The participation of companies that may be involved as investors or consumers and officials of the Authority who have current or recent connections to the companies involved, therefore, needs to be avoided.



4. The normal way to identify conflicts of interest is through self-declaration by consultants. Where a conflict exists, which has not been declared, competing companies are likely to bring this to the notice of the Authority. All conflicts must be declared as and when the consultants become aware of them.
5. Another approach towards avoiding a conflict of interest is through the use of “Chinese walls” to avoid the flow of commercially sensitive information from one part of the consultant’s company to another. This could help overcome the problem of the availability of limited numbers of experts for the project. However, in reality effective operation of “Chinese walls” may be a difficult proposition. As a general rule, larger companies will be more capable of adopting Chinese walls approach than smaller companies. Although, “Chinese walls” have been relatively common for many years, they are an increasingly discredited means of avoiding conflicts of interest and should be considered with caution. As a rule, “Chinese walls” should be considered as unacceptable and may be accepted only in exceptional cases upon full disclosure by a consultant coupled with provision of safeguards to the satisfaction of the Authority.
6. Another way to avoid conflicts of interest is through the appropriate grouping of tasks. For example, conflicts may arise if consultants drawing up the terms of reference or the proposed documentation are also eligible for the consequent assignment or project.
7. Another form of conflict of interest called “scope–creep” arises when consultants advocate either an unnecessary broadening of the terms of reference or make recommendations which are not in the best interests of the Authority but which will generate further work for the consultants. Some forms of contractual arrangements are more likely to lead to scope-creep. For example, lump-sum contracts provide fewer incentives for this, while time and material contracts provide built in incentives for consultants to extend the length of their assignment.
8. Every project contains potential conflicts of interest. Consultants should not only avoid any conflict of interest, they should report any present/ potential conflict of interest to the Authority at the earliest. Officials of the Authority involved in development of a project shall be responsible for identifying and resolving any conflicts of interest. It should be ensured that safeguards are in place to preserve fair and open competition and measures should be taken to eliminate any conflict of interest arising at any stage in the process.
