# Sub: Introduction of Goods & Service Tax (`GST') - Way forward

As you are aware GST is going to be implemented in India with effective from 1<sup>st</sup> July 2017.

Port is leaving no stone unturned for ensuring the compliance of GST law, latest by the last week of June 2017. Accordingly, it would be critical for all the stakeholders to be ready for the said change as it would involve transformation of various business functions like supply chain, accounting, IT and tax compliances.

In view of the above, this communication is being made to ensure that follow up steps are being taken well in advance, in order to ensure smooth transition. In this connection, we have highlighted certain key aspects that would be relevant from a GST standpoint.

### **Registration under GST**

- Registration is required to be obtained in every state from where a taxable supply of goods and/or services is being made.
- The Government has initiated the process of migration of the existing tax payers to GST and the provisional IDs and passwords are being provided to every tax payer registered under current Indirect tax legislations.

# Action requested: To obtain the necessary registrations immediately and make the details available to V.O.Chidambaranar Port Trust in the attached template as Annexure I to enable us to update our masters.

As the details sought by us in the attached template would be significant to enable you to avail credit of taxes so levied by V.O.Chidambaranar Port Trust, we earnestly request you to provide the same on or before **June 23<sup>rd</sup>**, **2017**.

Further, to enable you to update your masters, we have enclosed our registration details as **Annexure II** for your ready reference. We shall update the same as and when necessary.

# Input Tax credit

- One of the main objectives of GST is to create a seamless credit chain thereby reducing tax costs leading to an opportunity for businesses to work towards the same.
- In order to enable you to avail input tax credit, kindly provide us with your GSTN registration number as requested in Annexure 1 and also request you to ensure that timely payment of taxes is made to us. Also, the details uploaded by us in the outward supply return on the GSTN portal on monthly basis are required to be validated by you after the 10th but on or before the 15th day of the month succeeding the relevant period.

### Way forward

In order to ensure smooth transition into the GST regime and may please be furnished to the Port by due date of GST implementation itself. Accordingly, we request you to share with us all the relevant details on timely basis as and when sought by us required at the time of implementation.
