3. As Watchmen are being engaged under Un-Skilled Category, the wages are to be fixed as an Un-Skilled Category, which is coming under the Construction Industries shall be followed.

4. The Minimum wages being paid with effect from 01.04.2017 and the revised Minimum wages to be paid with effect from 01.10.2017, are one and the same and there is no change in the rates of wages. The Pre-revised rates and revised rates are the same, which are as follows:

The Minimum wages rates will be the same as it was during the period of 01.04.2017 to 30.09.2017, in the establishments falling under Govt. of India.
