Visakhapatnam Port Trust (VPT) invites application from interested parties (Applicants) in accordance with the Request For Qualification (RFQ) document in order to shortlist competent Applicants, subject to national security clearance, who may be subsequently invited to bid for the project.

RFQ document containing instructions to Applicants and Criteria for Evaluation may be obtained on payment of Rs. 35,400/- (Rupees Thirty Five thousand and Four hundred only) only through RTGS / NEFT / Bank Transfer etc on any working day between 1000 hrs to 1700 hrs from 05-10-2021 to 20-11-2021 from CME's Office of VPT.
