Poddar & Co., Chartered Accountant	As per Tender Conditions, Section-IV Clause-1(ii) The bidder has not uploaded the Comptroller & Auditor General of India(C&AG) Empanelment/Reserve Bank of India. As per clause1(a), Section III, all the Internal Audit Work order provided for similar work experience are ongoing works, do not meet the Experience criteria, also the bidder not provided the Work Completion Certificate which is mandatory. Hence, the firm is not considered for further evaluation.
2.	M/s. RSN & Associates., Chartered Accountant	As per Tender Conditions, Section-IV of Clause-1(i) The bidder has uploaded the Invalid MSME Certificate. Hence, the firm is not considered for further evaluation. As per clause-1(a), the Bidder has not attached any Work Completion Certificate. Hence, the Firm is not considered for further evaluation.
3.	M/s. K. Gopal Rao & Co., Chartered Accountant	As per clause-1(a), the Bidder has not attached any Work Completion Certificate which is mandatory. Hence, the Firm is not considered for further evaluation.
