## **UPPER AGE LIMIT**

Direct Contractual Personnel : The age should not be more than 55 years at the time of entry into the Pilotage service subject to regular and periodical medical examination as prescribed by the Port, however the upper age limit shall be upto 65 years.

**Tenure of engagement** : The tenure of the contract shall be for a period of three (3) years from the date of joining. The Pilot shall be required to serve for a minimum period of two (2) years from the date of issuance of the pilotage license. The contract period may be extended upon the request of the Pilot beyond the initial term, subject to the requirements of the Port, and satisfactory performance. Such intimation shall be done at least three months prior to the completion of the contract period.
