5. Consortium / JV companies shall not be permitted. No single firm shall be permitted to submit two separ ate tender applications.

6. Accommodations: On request of the contractor, the Port may provide quarters on contract rent basis, su bject to availability and such other conditions that the Port may impose from time to time.

7. As per the guidelines of OEM, consumables like Tyre, Tube, Lubricants, Filters, AC & all other accessories / spares to be replaced periodically

- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
