- In case you are engaging 20 nos or more labourer, the labour license may be obtained iv. from the Licensing Authority as per relevant Contract Labour Act.
- You shall comply with the Regulations and Byelaws of State & Central Government, v. the provisions contained in Labour Act, Minimum wages Act, Workmen Compensation Act, Employees Provident Fund Act, Employees State Insurant Act, 1948(34 of 1948) etc., and in accordance with the conditions of the Port's Tender Document.
