
Sir(s),

Since, you have fulfilled all the formalities as per letter under reference, it has been decided by the competent authority to award the aforesaid work to you, at your quoted rate amounting to Rs.15,48,990/- (Rupees Fifteen Lakhs Forty Eight Thousands Nine Hundred and Ninety Only) which is (-) 21.85% less over the estimated cost put to tender (i.e., Rs. 19,82,003/-

- The rates quoted by you are the firm price inclusive of all taxes but exclusive of GST. No Escalation is payable to you. Arbitration clause is deleted from the contract.
- The Date of commencement and completion will be treated as 11.01.2023 and 10.07.2023 respectively. (6 months)
- A formal contract agreement between you and this port has to be executed within 15 days from the date of issue of this letter.
- The work should be strictly carried out as per the stipulation of the contract/terms and conditions of the tender. No extra conditions what so ever will be entertained from your side.
- In case you are engaging 20 nos or more labours, the labour license may be obtained from the licensing authority as per relevant Contract Labour Act. You are required to apply for labour clearance certificate to the welfare officer, VOCPT after completion of work in the prescribed proforma, within one month from completion date.

- vi. The up to date Income Tax & PAN card, GST registration number must be submitted.
- vii. You shall comply with the regulations and bye-laws of State & Central Government, the provisions contained in Labour Act, Minimum Wages Act, Workmen Compensation Act, Employees Provident Fund Act, Employees State Insurance Act, 1948 (34 of 1948) etc., and in accordance with the condition of the Port Tender Document.
- viii. You are requested to contact the Assistant Engineer/Zone"B" and commence the work as per his instruction.
