#### 1. Pre-bid clarifications and Amendment to Tender document:

a) A pre-bid meeting will be held at 11.30 hours (IST) on 12.05.2023 through Video conference (Link will be sent to the bidders who show interest via mail) to offer clarifications required, if any, on the Tender document. This meeting will be held on this date unless otherwise notified. The tenderers are advised to examine the tender document carefully and if there be or appear to be any ambiguity or discrepancy in the documents, or any clarifications needed in the Tender Documents, these shall be referred to the Chief Engineer, V.O.Chidambaranar Port Authority, Tuticorin – 628 004 in writing well in advance so as to reach at least three days before the date fixed for the pre-bid meeting. It is to be noted that your queries should be in word format only to the email: ce@vocport.gov.in no queries seeking clarifications will be entertained after the pre-bid meeting.

- b) The compilation of questions raised and answers given will be posted in the VOCPA website and will bind all the tenderers. Any modification of the tender document which may become necessary as a result of the pre-bid clarifications will be made by the Employer exclusively through the issuance of an addendum and the pre-bid clarifications of the Authority shall form the part of this tender document.
- c) At any time before the submission of bids, the Employer may, for any reasons, whether at its own initiative or in response to a pre-bid clarification modify the document by amendment. The amendment will be notified in VOCPA/e-tender website only and will be binding on them. The Employer may at its discretion also extend the deadlines for the submission of proposals. Hence, the tenderers are requested to keep watching the VOCPA website regularly till the due date for bid submission.

### 2. Responsiveness of Tender

- i. Earnest Money Deposit (EMD) to be furnished as per Clasue 6.2 of Section-II.
- ii. Undertaking by the tenderer that the credentials submitted are true and duly attested by Notary Public.
- iii. The tenderer has to submit the undertaking as **Form I (C)** viz, Tender acceptance letter with the tender document, failing which the tender will not be considered for evaluation.

The tenderer should submit the above documents (i), (ii) & (iii) in the e-tender, failing which their offer will be treated as non-responsive and their bid will be summarily rejected without technical evaluation.

### 3. Minimum qualifying criteria:

The Tenderer shall meet the minimum qualifying criteria as follows:

a) <u>Work Experience:</u> The tenderer should have successfully completed *similar work* as detailed below during the **last Seven years ending April**, **2023** with either of the following:-

Three works, each costing not less than Rs.1,79,92,440/-

(or)

Two works, each costing not less than Rs.2,24,90,550/-

(or)

One work costing not less than Rs. 3,59,84,880/-.

**Similar work means** "Construction of offshore structures including Demolishing / Dismantling of offshore piles / offshore wharf / offshore foundations etc.,"

(Or)

Demolishing / Dismantling of offshore piles / offshore wharf / offshore foundations etc.,"

#### Note:-

If the work completion certificate furnished is from other than Govt. Departments by the tenderer to fulfill the requirement of MQC, the same shall be supported with TDS certificate (FORM-16A) issued by the department where the work was executed for full executed amount of the work otherwise such work experience shall not be considered.

b) <u>Financial Position:</u> Average annual Financial Turnover of the Tenderer during last three financial years (i.e) 2019-20, 2020-21 & 2021-22 shall be at least Rs.1,34,94,330/-

**Note:** Conversion of foreign currency into Indian Rupees for evaluation purpose: 1 USD = Rs.82/-. Other currencies will be equated to USD and then to Indian Rupees.

- 4. The tender document is open to firms / companies / voluntarily formed Joint Ventures / Consortia, meeting all the Minimum Eligibility Criteria as stipulated hereinabove.
- 5. The joint venture must satisfy collectively the eligibility criteria as described in this section. For this purpose, the following information of each member of the joint venture may be submitted which will be added together to assess the collective eligibility criteria:
  - (i) Average Annual Turnover
  - (ii) Specific work Experience
  - (iii) Capacity of key Personnel
  - (iv) Ability to own / lease relevant equipment

Each JV Partner including the lead partner shall meet not less than 26% of the following criteria:

- (i) Average Annual Turnover
- (ii) Specific work Experience
- The evaluation will be done only based on the information, evidence documents, records particular furnished by the tenderers and hence the tenderers are requested to furnish adequate, relevant information along with requisite documentary evidences and without any omission.
- 7. If any information furnished by the tenderer is found to be concealed or false at a later stage, the contract will be terminated forthwith without prejudice to the rights thereon, consequent on termination and the contractor will be banned to participate further VOC Port tenders for three years period.

- 8. Criteria regarding satisfactory performance of works, personnel, establishment, etc., shall also be uploaded according to the requirement of the project in the relevant formats given in the Tender Document (Technical Bid).
- 9. The tender documents can be downloaded from VOCPA Website **www.vocport.gov.in** through "E-tendering link: https://etenders.gov.in/eprocure/app.
- 10. The E-Tender submitted by the firm will not be considered who has pending litigation against VOCPA or blacklisted contractors. If such tenderers submit the tender document downloaded from the website, the same will not be considered.
- 11. The EMD payment should be made only through online payment gateway mode in CPP Portal, without which the Tender will not be considered. EMD in any other form will not be accepted.
- 12. Tenders which are in any way incomplete will not be considered. The Port reserves the right to waive any formality thereof or to reject any or all the tenders without assigning any reasons thereof.
- 13. Port shall not be responsible if the tenderer is not able to upload all the relevant documents due to technical reasons, the bid will not be considered.
- 14. The Tenderer shall furnish the GST Registration Certificate and ESI & EPF,
- 15. The Price Bid of those Tenderers who have qualified vide Para 3 above shall be opened at a later date which will be intimated to all concerned.
