- 1. Electronic Tenders (Online) are invited in 'SINGLE *BID TWO COVER SYSTEM*' on behalf of V.O.CHIDAMBARANAR PORT TRUST (VOCPT) from reputed and experienced Government and Private e-auctioneers for the work of conducting e-auction of the Tug M.T.Thiruvalluvar of V.O.Chidambaranar Port Trust.
- 2. Tender Document having all details is available at the URL of the e-Tender Portal https://etenders.gov.in/eprocure/app. The interested bidders are needed to register their name in the website https://etenders.gov.in/eprocure/app. The tender documents are required to be submitted only through e-mode offered in the website https://etenders.gov.in/eprocure/app. Tenders in any other manner will be rejected and no correspondence on such matter will be entertained
- 3. VOCPT will not entertain and will not accept any reasons of bidder due to Net Connection Failure/Current Connection Failure and any issues during the filling of tender online. Bidder will be responsible for all those facts and failure of Net Connectivity, Current Connectivity and they should be at their own risk. VOCPT will not take any liabilities and claims for failure of Network and problem arise during the submission of the tender forms online.
- 4. VOCPT may verify the original documents with the documents scanned and submitted by the bidder in the e-tender portal, at any time during the tendering process.
- 5. The tender document submitted by the bidders who had litigation against the VOCPT will not be considered. If such bidders submit the tender document downloaded from the web site, the same will not be considered.

SECTION - I SCOPE OF THE SERVICES

- The scope of services (Scope) shall comprise the following, but not limited to:
 - The e-auctioneer/Service provider shall be expertise in providing contract preparation, market development, risk management, efficient price discovery, clearing and settlement.
- ii. The e-auctioneer/ Service provider would depute a resource to coordinate with VOC Port Trust on continual basis.
- iii. The e-auctioneer/ Service provider should identify the buyers in way of extensive marketing.
- iv. The trading timing for the e-auction will be fixed by V.O.Chidambaranar Port Trust and the e-auctioneer/ Service provider shall enable the e-auction successfully.
- v. The Highest bidder (H1) would be entitled as winner for purchase of the TUG M.T.Thiruvalluvar being auctioned and price after due recommendations of VOC Port.
- vi. To submit the final report after the completion of e-auction process.
- vii. To follow up the successful bidder/ buyer for making final payment as per the quoted and approved prices.
- viii. To ensure the disposal of the tug M.T.Thiruvalluvar from the port area after completing all the statuary, legal and commercial formalities by creating a delivery order and generating an Invoice through the system.
 - ix. E-auction system should be transparent/user friendly for bidders/ buyers for easy participation in e-auction.
 - x. The successful e-auctioneer/ service provider should provide extensive training to the interested bidders/ buyers so as to ensure maximum participation of bidders/ buyers in the e-auction platform.
- xi. E-auction platform shall ensure facility for the bidders/ buyers to participate anywhere from India without any difficulties and there is no need of submitting physical auction registration form to seller or auctioneer.
- xii. The e-auctioneer/ service provider should upload maximum photographs and videos of the Tug M.T. Thiruvalluvar in the e-auction website so as to ensure the bidders/ buyers to know the present condition of the equipment.

SECTION - II GENERAL CONDITIONS OF TENDER

2.1 General:

On behalf of the Board of Trustees of the V.O.Chidambaranar Port Trust, the Chief Mechanical Engineer, V.O.Chidambaranar Port Trust invites E-tenders from reputed Government / Private e-auctioneers for conducting e-auction of Port Tug M.T.Thiruvalluvar of VOCPT.

The used M.T Thiruvalluvar, 32 Ton Bollard Pull Tractor Tug, was inducted in Port fleet during 1995 and is being deployed in Port operation. The tug has completed its economical life period during 2015. The principal dimensions of the used M.T Thiruvalluvar 32 Ton Bollard Pull Tractor Tug are as follows.

2.4 The following scanned copy documents to be uploaded while submitting tender:

- 2) The scanned copyof GSTIN No. & Certificate of Registration shall be enclosed along with tender to be uploaded.
- 3) A tender acceptance letter confirming validity of the proposal for **120 days** and detailing contents of the proposal including list of enclosed documents (Annexure 1).
- 4) Power of Attorney in the name of the person/s signing the bid documents.
- 5) The e-auctioneer should confirm that there is no conflict of interest in taking up this assignment by submitting an undertaking to the effect that, they /their affiliates will not bid for/ rate the same project.
- 6) A statement supported by documentary evidence establishing fulfillment of all the Minimum Eligibility Criteria by the Bidder/s as per the General Terms and condition as mentioned in the Clause 2.5.
- 7) Corporate information of Bidder as per Annexure-2.
- 8) Duly Notarized details in respect of background of the e-auctioneer/s past experience, copies of work orders issued by the clients for conducting e-auction during the period of three years out of last seven years, copies of Selling Agency Agreements/ Work orders/ Completion certificates entered by the e-auctioneer with the clients in respect of the e-auctions executed in past, current e-auctioning activities during the three financial years out of last seven years ending 31st March 2020 likely to be involved in executing this assignment as proof of experience as per **Annexure-3**.
- 9) Compilation of pre-bid queries / answers, if any, with each page initialed by the authorized signatory in token of having been read and accepted by the party.

The Schedule of Prices to be indicated in the respective columns shown in the e-tendering Website as per the format set out in **Annexure-4**. (Financial Bid)

The completed tender should be submitted through online in e-tender website Tender Wizard on or before 24.06.2021 up to 15.00 Hrs. The online submitted tenders will be opened in the e- tender website Tender Wizard on 25.06.2021 at 15.30 hours, in the presence of tenderers who wish to be present at the time of opening.

2.5 Minimum Eligibility Criteria:

- 1. The e-auction Software of service provider should be certified by Standardization Testing and Quality Certification Directorate [STQC] Ministry of Electronics and Information Technology and also to comply with the latest CVC Guidelines, DIT Department of Information and Technology, Government of India (copy of certificate to be submitted) and should comply with Central Vigilance Commission's guidelines for e-procurement applications General Finance Rule 2005 [GFR] and Information Technology Act, 2000 and its amendments, 2008.
- 2. (a) The e-auctioneer/ service provider shall have minimum experience of at least three (3) years out of last 7 years in business of conducting e-auction. The e-auctioneer/ service provider should furnish self-attested copies of work orders issued by their clients for conducting e-auction during the period of three years out of last 07 years and/or self-attested copies of Selling Agency Agreements / work orders / completion certificate entered by them with their clients as proof of experience.
 - (b) The e-auctioneer/ service provider shall have experience as above for conducting e-auction for any of the following organizations:-
 - (i) Any Commissionerate of Customs.
 - (ii) Any Major Port Trust.
 - (iii) Airport Authority of India.
 - (iv) Any Public Sector Undertaking.
 - (v) Any CFS/ICD, (Any organization under State Central Government Public Sector Banks)

(c) The e-auctioneer/ service provider shall have earned at least Rs.5,60,504/-[Rupees, Five lakhs, sixty thousand, five hundred and four only] on an average during three years out of last 07 years as professional /auction fees by way of conducting e-auction on behalf of their clients during the three financial years out of last 07 years ending 31 March 2020.

As a proof of average income of Rs.5,60,504/-[Rupees, Five lakhs, sixty thousand, five hundred and four only]earned by them through professional /auction fees during the three financial years out of last 07 years, the e-auctioneer/service provider should submit Notarised copies of Income & Expenditure Accounts and Balance Sheet duly certified by Chartered Accountant. Proof of receipt of contract price to be attached.

- (d) The e-auctioneer/ service provider shall have conducted at least 10 e-auctions during three financial years out of last 07 years. The e-auctioneer/ service provider should submit copies of the relevant auction list / tender list / e-auction notice / copy of bills received as evidence.
- (e) The e-auctioneer/ service provider shall furnish documentary evidence for points mentioned above and duly signed all the Annexure enclosed, in absence of which their offer will be rejected.
- 3. e-auctioneer/ service provider should submit undertaking that they have not been blacklisted / debarred from services in any Central or State Government organization PSU or any other organization.

Note: The tender which does not satisfy the pre-qualification criteria as mentioned above shall summarily be rejected and shall not be considered for further evaluation.

2.7 Time for Completion:

The whole assignment has to be completed in a maximum period of three months from the date of issue of work order.

Normally extension of time for completion of the e-auction process is not entertained. However, considering the valid reasons or the circumstances arises beyond the control of e-auctioneer, based on the written request received from the e-auctioneer the Authority may consider for granting the extension of time.

2.8Rates to be Figures and Words:

The tenderer shall quote the rate / percentage of rate in Indian Rupees and in English, in figures as well as in words inclusive of, Customs duty import duty, GST etc., the rates tendered by him in the concerned proforma of the tender and in such a way that interpolation is not possible. The tendered amount for the work shall be entered in the tender form and duly signed by the tenderer and enclosed and sealed in cover No.2. In case of any discrepancy between figures and written words, the rates in words shall be taken as the quoted price.

2.9 Correction/Variation:

- (i) All corrections and alterations in the entries of the tender documents shall be attested with full signature of the tenderer with date. No erasures or over-writings are permissible.
- (ii) The tenderers should not send any revised or amended offers after the opening of the tender. No such document will be entertained. The Board also do not accept offers with the price variation clause.
- (iii) The prices and amounts entered in the schedule of price shall represent the tenderers offer for the work generally in accordance with work specifications and purpose given in this tender.
- (iv) Deviation: Tender should be completed in all respects for taking a decision immediately on opening of the tender. In the absence of tenderers disagreement to any particulars clause, it will be construed that they are agreeable to such ports conditions where they have not expressly deviated.

2.10 Signing of Agreement:

Within 15 (fifteen) days from the date of issue of Letter of Award / Work order, the successful Bidder / service provider shall sign a formal agreement (Annexure-5)as annexed in the Bid Document.

2.11 PERFORMANCE BANK GUARANTEE:

(i) The contractor shall deposit an amount of Rs. 6,72,605/- [Rupees. Six lakhs, seventy two thousand, six hundred and five only] as Performance Bank Guarantee and it shall be paid through RTGS /NEFT to V.O.Chidambaranar Port Trust, Tuticorin or shall be paid through irrevocable Bank Guarantee obtained from the Nationalised / Scheduled Commercial bank having net worth of above Rs.100 crores having its branch at Tuticorin and payable at Tuticorin, in the form as per specimen in Annexure–7.This Performance Bank Guarantee will be refunded only after satisfactory completion of the work. The Performance Bank Guarantee will not bear any interest

- (iii) A letter from the Bank shall also be sent along with the Performance Bank guarantee directly to the Employer within 15 days of placement of work order or before the commencement of work whichever is earlier. However, the Chief Mechanical Engineer may relax the time limit of 15 days and extend it by further period of 10 days in extraordinary circumstances for the reasons recorded by him. If the performance Bank guarantee is not deposited in time as prescribed above, the work order shall stand cancelled automatically and the bidder will be suspended for a period of one year. The performance Bank guarantee should be valid till the completion of the e-auction or for a period of 3 months ,which ever is latter. The Performance Bank guarantee will remain in force throughout the period of contract of tender as specified in the tender document of this tender and will be refunded thereafter.
- (iv) The contractor shall furnish the Performance Bank guarantee towards performance security by the issuing bank directly to the port. The amount as stated will not bear any interest. Bank Guarantee, obtained from the Nationalized Bank /Scheduled bank in the format prescribed by the Port, Shall be in compliance with for a digital confirmation for the Bank Guarantee and the BG not complying with this shall not be considered.
- (v) The Bank Guarantee shall be refunded without any interest after the successful completion of the contract. If the E-AUCTIONEER fails to perform or observe any of the conditions of contract, Port Trust will be at liberty to deduct any amount due to Port Trust under this contract from Performance Bank guarantee /any sums of money due or that may become due to the e-auctioneer. This is without prejudice to the rights of the Port Trust under the terms of this Contract.
- (vi) The Performance Bank guarantee furnished towards the performance security shall be valid till the completion of the e-auction or for a period of 3 months, whichever is latterand shall have a claim period of three months after successful completion of e-auction. In case of extension of e-auction period, Bank Guarantee has to be extended for a further period as required by V.O.Chidambaranar Port Trust to cover the extended e-auction

period. Any expenditure in this regard will be borne by the eauctioneer.

2.12Witness:

Witness shall be persons of status and property and their names, occupations and addresses shall be furnished below their signatures.

2.13All pages to be signed:

All signatures in the tender documents shall be dated. All pages of all section of the original tender documents shall be signed with date and seal at the lower right hand corner and also signed wherever required in the tender document by the tenderers or by a person holding power of attorney to sign on behalf of the tenderer before submission of the tender.

2.14Right of the Board to accept or reject the Tender:

The Board does not bind itself to accept the lowest tender and reserves the right to reject any or all tenders received without assigning any reason, whatsoever. Tenders in which any of the particulars and prescribed information are inadequate or incomplete in any respect and / or the prescribed conditions are not fulfilled are liable to be rejected. Canvassing in any form by the tenderers will result in their tender being rejected.

2.15Transfer of Tender Documents:

Transfer of tender documents purchased by one intending tenderer to another is not permissible.

2.16Taxes & Duties including GST:

GST If any chargeable extra, may be clearly indicated in the price schedule available in the e-tendering website.

Goods and Services Tax:

- 1. As per GST Act, invoice in the prescribed format has to be issued by a registered dealer on or before the time when goods are removed for supply(where supply involves movement) on or before the time when delivery is received by the recipient(where movement of goods is not involved)
- 2. The law has laid down conditions to avail GST input tax credit on supply of Goods or services. All of the following conditions need to be satisfied to avail GST input credit:
 - The dealer should be in possession of Tax Invoice/Debit or credit Note/Supplementary Invoice issued by a supplier registered under GST Act.
 - The said goods/services have been received.

- Returns (GSTR-3) have been filed
- The tax charged has been paid to the Govt. by the supplier
- 3. As a service provider, contractors /professionals etc shall issue the invoice within 60 days to the Port from the date of providing service. If the invoice is not issued within the time limit, then penalty and/or interest shall be applicable. If any of the contractors/ professionals do not issue invoices as aforesaid and do not file tax return by due date, Port cannot avail the ITC. Further, Port has to pay the said ITC availed with interest and penalty as applicable under GST rule. Therefore, in the event of default of the contractor on the above grounds, the said amount paid/payable to the Government by Port shall be recovered from any money due to the contractor or adjusted against the performance security/security deposit.

a) Income Tax

Income Tax and surcharge as applicable will be deducted at source by V.O.Chidambaranar Port in accordance with Income Tax Act at the rate applicable from time to time and in accordance with instruction issued by INCOME TAX Authorities on this behalf from time to time. The consultant shall furnish his PAN details or a copy of Income Tax exemption certificate if any.

b) GST-TDS: - GST TDS will be recovered as per GST Act.

<u>C) GST:-</u>

The firm shall furnish GSTIN Number and copy of certificate of registration duly attested by Notary.

2.17<u>Opening and Acceptance of Tender:</u>

Cover-I containing the technical documents to shortlist the eligible tenderers will be opened through e-tender procedure on the scheduled date and time i.e., on 25.06.2021 at 15:30 hrs in the presence of such tenderers who wish to be present at the time of opening.

After the verification of first cover and getting the required technical/commercial clarifications based on the information given, Port Trust will prequalify the eligible tenderers.

The cover 2 containing the price bid document will be opened through e-tender only for those tenderers who are shortlisted and technically pre- qualified in cover-I. The date and time of opening of the No.2 cover will be informed to the qualified tenderers.

Tenders submitted by tenderers shall remain valid for acceptance for a period of 120 days from the date of opening of the tenders. The tenderers will not be allowed during the declared period of validity to revoke or cancel his tender or to vary any term thereof, without the consent in writing of the Chief Mechanical Engineer.

2.18 Addenda / Corrigenda:

Addenda/Corrigenda to the tender documents will be issued by the Chief Mechanical Engineer prior to the date of opening of the tenders, to clarify or reflect modifications in the contract terms and conditions.

Such addendum/corrigendum will be uploaded in the tender wizard and Port website. Tenderers who are unable or unwilling to bring their tenders to conform to the requirements of the Board are liable to be rejected.

2.19 Collection of Data - Tenderer's Responsibility:

The tenderer shall visit the Port and acquaint himself fully with the existing conditions of the Port Tug M.T. Thiruvalluvar as the e-auction is to be carried out on "As is where is Basis" and no claims whatsoever will be entertained on the plea of ignorance or difficulties in the execution of the e-auction. Before submitting the tender, the tenderer shall be deemed to have clearly understood and satisfy himself regarding the work and services for conducting the e-auction, all conditions liable to be encountered during the execution thereof and that prices, rates and/or compensation quoted in the offer are adequate and all inclusive with respect to all factors, circumstances and conditions likely to be incidental, both direct and indirect, to the work and services.

The prices and amount quoted by the tenderer shall allow for all costs, including escalation of labour, transport, insurance fees, increase in cost due to government and other charges, cost of documents to be submitted, direct and indirect, till the e-auction work is completed in accordance with the scope of the e-auctioning service and contract period.

2.20 Tenderer's Comments:

Any comments which the tenderer desires to make shall not be placed in the annexed documents but shall take the form of a separate statement in the English language and giving reference to page, clause or item numbers and shall be submitted along with the tender in the cover No.1.

2.21 Signing the Contract:

The successful tenderer shall be required to execute an agreement in the proforma prescribed by the V.O.Chidambaranar Port trust (draft enclosed in the document) on Tamil Nadu Government State stamp paper of the required value within 15 days from the date of issue of the notice of acceptance of the tender. In the event of failure on the part of the successful tenderer to execute the agreement within the above stipulated period, or the period agreed by the Port, the Earnest Money or security deposit deposited by him will be forfeited and apart from that the Board being in such circumstances entitled to treat the successful tenderer as in breach of contract and proceed accordingly.

2.22Determination of Responsiveness:

The tender which does not satisfy the terms and conditions as mentioned in the tender, shall summarily be rejected and shall not be considered for further evaluation. The VOCPT will scrutinize tenders to determine whether the tender is substantially responsive to the requirements of the tender document. For the purpose of this clause a substantially responsive tender is one which inter-alia confirms to all the terms and conditions, general conditions of the entire tender documents without any deviation (or) reservation. A tender which in relation to the estimated rates, is un-relating will be rejected as non- responsive. The decision of the Port shall be final in this regard.

2.23Instructions to Tenderers to form Part of the Contract:

All these instructions conditions, special conditions, if any, work specifications contained in the tender document and any correspondence related to this Contract shall form part of the agreement.

2.24Liquidated Damages:

If the e-auctioneer fails to complete the e-auction process within the time specified as said under Clause 2.7 of this or within the extended time that may be allowed by the Employer, the e-auctioneer shall pay or allow to the Board to deduct a sum of equivalent to 1% per week or part thereof of the total value of the contract subject to a maximum of 10% of the total accepted value of contract as liquidated and ascertained damage and not by way of penalty, beyond the said period or extended period as the case may be during which the work remain unfinished. The liquidated damage will be deducted

from any money due or become due to the e-auctioneer. The payment of such liquidated damage shall not relieve the e-auctioneer of his obligations to complete the assignment or from any other of his obligations or liabilities under this e-auction.

- 2.26 Any Tender not conforming with the foregoing instructions will not be considered. The Employer does not bind himself to accept the lowest or any Tender and has the right to reject any Tender without assigning any reason and without any liability. No representation whatsoever will be entertained on this account.
- **2.27** No foreign exchange is available for this work. All payments will be made only in Indian Rupees only.
- 2.28 The Tenderer should abide by this Tender for a period of 120 (one hundred and twenty) days from the date fixed for receiving the same or for such other periods as may be mutually agreed upon and it shall remain binding upon the Tenderer so that the Tender may be accepted at any time before the expiry of that period.
- 2.29 Canvassing in connection with the Tender is strictly prohibited and the Tender submitted by the Tenderer who resort to canvassing will be liable for rejection.
- **2.30** The Technical Bids of the Tenderers will be evaluated based on the whole work. The entire work may be entrusted to a single Tenderer.

2.31Termination of Contract:

In the event of continued unsatisfactory performance or non-compliance with any of the provision of the above said service, this Port reserves the right to cancel the consultancy service and forfeit the EMD and security deposit without giving any notice.

Note:-

- (i) Each payment should be made in Indian Rupees only on acceptance of the e-auction value by the Port Authority.
- (ii) All the documents / reports including primary data shall be compiled, classified and submitted by the e-auctioneer to V.O.Chidambaranar Port Trust in hard / soft form apart from the documents mentioned elsewhere in this document.
- (iii) In the event of discontinuance of the contract during currency of the eauction/ assignment, the Employer and Employer's decision in this regard shall be final.
- (iv) The tug M.T.Thiruvalluvar will be released to the client quoted for the highest price in the e-auction carried out by the e-auctioneer, only after issue of completion certificate by the Chief Mechanical Engineer.

2.32Work to be done to the Satisfaction of the Engineer:

Towing of the tug from the designated areas to out of the VOCPT waterline/ premises is in the Scope of the Buyer. The buyer will be allowed to tow the tug out of the VOCPT waterline once complete payment is received. They will be given 30 days to tow away the tug from the port.

1.8 Penalties:

The entire Pre bid Security amount will be forfeited if the HI Buyer fails to deposit payment within the given stipulated time. Beyond the allotted time for towing, the HI buyer will be charged 1% of the sale value per week along with applicable GST. Beyond 2 weeks, the buyer will lose the ownership of the tug and VOC Port/OR auctioned service provider will have the right to re-sell the tug.

1.9 Refund:-

Registration can be done online by forwarding the application form backed up by the necessary documents to any of the front offices of service provider. After the registration, all-prospective Buyers will have an auto generated "Unique User ID" & a "password" based on which they can log in. Both domestic as well as international bidders are eligible to participate.

2.4 GENERAL RULES AND REGULATION GOVERNING CONDUCT OF ONLINE AUCTIONS ON THE "SERVICE PROVIDER" PLATFORM:-

2.4.1 Introduction:

3. Prospective bidders are advised to read through the key terms pertaining to the online Forward Auctions as provided here:

- 3.1 <u>Definition of Key Terms Auction</u>: Auction refers to a forum where the sale for lot is stated and the participants (bidders) are required to bid up the price to be selected to purchase the requirement.
- <u>3.2 Auctioneer</u>: The Online Auction service provider, in this case service provider services limited.
- 3.3 Online Auctions: Online auctions refer to those auctions conducted through the
