New Delhi, the 30<sup>th</sup> September, 2021

G.S.R. (E). - In exercise of the powers conferred by section 157, read with sections 30, 30A, 41, 41A, 53, 54, 56, sub-section (3) of section 98 and sub-section (2) of section 158 of the Customs Act, 1962 (52 of 1962), the Central Board of Indirect Taxes and Customs hereby makes the following regulations further to amend the Sea Cargo Manifest and Transhipment Regulations, 2018, namely: -

1. Short title and commencement. - (1) These regulations may be called the Sea Cargo Manifest and Transhipment (Eighth Amendment) Regulations, 2021.  
(2) They shall come into force on the date of their publication in the Official Gazette.
2. In the said regulations, in regulation 15,-
  - a. in sub-regulation (2), for the words, figures and letters, "till 30<sup>th</sup> September, 2021", the words, figures and letters, "till 31<sup>st</sup> December 2021" shall be substituted.

**Subject : Filing of Arrival Time (AT) message by Kolkata Dock System/Haldia Dock Complex pertaining to follow Export process under Sea Cargo Manifest and Transhipment Regulations, 2021**

Sir,

Please refer to Notification No. 78/2021- Customs (N.T.) dated 30<sup>th</sup> September, 2021 (copy enclosed) issued by Central Board of Indirect Taxes and Customs where it is mentioned that Sea Cargo Manifest and Transhipment Regulations(SCMTR), 2021 will come into force on 31<sup>st</sup> December, 2021.

In pursuance of above notification and complying Sea Cargo Manifest and Transhipment Regulations, 2021, it is required to file all the relevant messages under Export process by the different stakeholders i.e Custodian, Transhipper, Agents as well as Port Authorities (ATO). Further to complete the export process, Port Authority has to file Arrival Time Message (AT) on mandatory basis against arrival of each consignment. Export process flow under aforesaid regulation is enclosed herewith for your reference.

In view of above, you are requested to file Arrival Time (AT) message so that all the message filings under export process may be completed.
