V. O. - iv) Administrative clearance of the concerned Organisation, as per enclosed proforma (Annexure-III).
- v) Vigilance report is to be furnished in the format prescribed, vide Ministry of Shipping's letter No.A-12022/10/2005-PE.I dated 27<sup>th</sup> August 2010, copy of which is attached as **Annexure-IV**.
- vi) The veracity of the qualification certificates and caste certificate submitted by the applicant are ensured and certified.
- vii) Two recent passport size photographs.
- 3. The selection is by merit for which overall grading in the ACRs / APARs will not be below "Very good". The crucial date for eligibility criteria will be determined as on the last date of receipt of application.
