M/s Coresonant Systems (P) Ltd,	As per Section V of clause 13 the parties who have outstanding dues to be paid to the Port as on the date of publication of the NIT shall clear the same before submission of the, else they will not be allowed to take part in this tender and the online uploaded bid document in any way will not bind the Port to accept their participation in the subject tender. The firm has pending dues for the work executed in the project "Management and operation to Toll Gate at Check Post No: I and II of VOCPT- collection of penalty amount on over staying of vehicles and capturing dwell time of commercial vehicles for a period of five years. Hence, the bidder is not considered for further evaluation.
02.	M/s Abhay Techno Services (P) Ltd	As per Section XII (Annexures and Forms), Annexure A, Form III (b) in case of experience other than Central / State Government / Autonomous bodies / PSEs / PSUs / Nationalized Banks / Public Limited Companies, the bidder has to provide the details of the TDS certificate in the form III (b) and shall submit TDS certificate for the past experience to be uploaded, only then the experience will be considered. The firm has not submitted the details of the TDS

		certificate in the form and not submitted the TDS certificate. Hence, the bidder is not considered for further consideration.
03.	M/s Parklens India (P) Ltd	As per Section VI clause B iii) the bidder did not fulfill the eligibility condition. Hence, the bidder is not considered for further consideration.
