<u>Sub:</u> Simplification of Advocate nomination with the proforma for approval of Competent Authority for cases filed by and against V.O.CHIDAMBARANAR PORT TRUST – Reg

It is observed that, the nomination of Advocate for the cases takes more time affecting the further legal processing before the court to comply with court requirements, which is strictly time bound. Hence to simplify the nomination process, a proforma for nomination will be sent to the Competent Authority by the legal section, on receipt of any court notice, legal notice, private notice, Affidavit and /or other legal document from the Concerned Department.

- 2. In view of the above, all the HoDs are therefore requested to ensure that upon receipt of any court notice, legal notice, private notice, Affidavit and / or other legal documents the same is forwarded to the Legal section immediately (i.e.) the very next day, with the brief details about the nature and importance of case and with reference to the previous case (if any), so that Legal section could get nomination for Legal advisers from the Competent Authority as per the applicable schedule of Legal Advisers maintained by L & DAS, and after obtaining the approval, the same will be sent to the Concerned Department for further necessary actions in the respective legal cases. This may be circulated among all the Officers and Employees for the strict compliance of the same.
