SOP FOR HANDLING SUB-CONVENTIONAL AERIAL PLATFORM THREATS

Subject: Permission to use drones in the Port operational area

Introduction:

Any request to use drones for the purpose of film shooting or any other purpose connected to cargo operation, within the Port premises, shall be examined by the Port authorities and permission shall be issued with conditions to operate the drone safely on a case to case basis.

Objective:

The objective of the SOP is to standardize the operating procedure before issuing permission to use drones in the premises.

Procedure:

- 1. For using drones in Port area for commercial purpose olike film making or cargo related purpose, a request shall be put up to the Deputy Conservator.
- 2. The prescribed form shall be duly filled and enclosed.
- 3. The Deputy Conservator, after examining the request, may grant permission to use the drone in the Port premises. The following details shall be checked before issuing permission:
 - i) Purpose of use
 - ii) Location and area
 - iii) Authorization from DGCA (Director General of Civil Aviation)
 - iv) Safety measures
- 4. One copy of the permission shall be forwarded to CISF for their monitoring.
