- The volume, slab and voyages achieved during the extended period i.e from 01.01.2024 to 31.03.2024 shall be treated separately and not in cumulative with the previous scheme period.
- Scheme 5 is not applicable for the extended period.
- New cargo shall be defined as any cargo not handled during the past three years i.e from 01.01.2021 to 31.12.2023 and will be eligible for claim under this Scheme.
