- iii. Aadhaar Card
- iv. Blood Group
- v. Photo
- vi. Mobile Number
- vii. Valid Driving License (Applicable for Drivers)

B) Vehicles/Equipment's:

- i. Duly Authorized proof of work, issued by the Direct Port Users.
- ii. Copy of Valid Registration Certificate.
- iii. Copy of Valid Pollution Control Certificate.
- iv. Valid Insurance Certificate.
- v. Copy of Valid Cargo and Gear Certificate (Applicable for Equipment).
- vi. Valid Guarantee Bond (Applicable for Annual Permit).
- 3. The cost of Annual Harbour Entry Permit (HEP) is as per Clause 5.09 of the Scale of Rates for VOCPA. Additional charge is applicable for new card.
- 4. The request for Harbour Entry Permit along with details of persons shall be made on or before 20.06.2025.
