TRADE NOTICE

VOCPA proposes to introduce a MGT based "Preferential Berth Allotment Scheme 2023". The scheme is extended to all importers who guarantee to handle One Million Metric Tonne of dry bulk cargo (other than coal). Priority berthing shall be provided to vessels without restriction in berth stay subject to the following conditions:

- The Importer shall apply for the Preferential Berth Allotment Scheme 2023 committing an MGT of 1 MMTPA for handling dry bulk cargoes other than coal at VOCPA for the year 2023.
- ii. The Importer shall submit the following documents along with the application for the scheme:
 - a. Commitment letter for handling the MGT volume of 1MMTPA at VOCPA in the prescribed format
 - b. Irrevocable Bank Guarantee (BG) equivalent to Wharfage charges (as per General SoR 3.1.1. Sl.No.4 Dry Bulk (xvii) Others Not Specified) plus applicable GST(i.e., @18%) for 1 MMT, in favour of FA&CAO, VOC Port Authority, drawn in any scheduled bank payable at Tuticorin branch valid till 31.03.2024, with a claim period upto 30.06.2024.
 - c. Undertaking Letter to handle the MGT of 1 MMT of dry bulk cargo other than coal, failing which / and in the event of a shortfall in the handled quantity, express No Objection to encashment of the BG to the tune of the applicable wharfage charges plus GST for the shortfall quantity by the Port
- iii. Request for priority shall be entered through NLP Marine.

- iv. Parameters for berthing of vessels shall be according to the Trade Notice dated 08-08-2019.
- v. Berthing and Shifting of vessels shall be according to the Berthing Policy for berthing of vessels at VOCPA published on 22-09-2020 and Trade Notice dated 12-04.2019.
- vi. Vessel & Cargo related charges including priority berthing charges, as per General SoR, shall be paid before berthing of the vessel. However, if the vessel is berthed under normal arrival priority, no priority charges shall be collected for that vessel.
- vii. Priority berthing shall not be extended to vessels carrying part cargo. Cargo discharged from vessels berthed on normal arrival priority including part cargo vessel shall also be accounted for the MGT.
- viii. Coastal cargo shall not be accounted for MGT.
- ix. Berthing will be provided based on the IGM and Cargo shall be accounted based on the Importers name & IE Code in the Customs OOC document for the MGT.
- x. Interested Importers shall apply to the Port on or before 31.01.2023.
- xi. This scheme shall be valid for one year from the date of acceptance issued by the VOCPA.

In the event of failing to achieve the MGT within the scheme period, we shall remit the Wharfage charges plus applicable GST equivalent to the shortfall quantity within 31 days from the completion of the scheme. In the event of failing to pay for the short fall amount, we have no objection, to encash our Bank Guarantee, equivalent to the Wharfage charges plus applicable GST for the shortfall quantity by the Port without any notice.

- 2. The Bank hereby undertakes to pay the amount due and payable under this Guarantee without any delay and demur or protest, merely on a demand from VOCPA. Any such demand made on the Bank shall be conclusive as regards the amount due and payable by the bank under this Bank Guarantee.

- 3. The Bank undertakes to pay to the Beneficiary money so demanded not withstanding any dispute or disputes raised by MGT provider(s) in any suit or proceeding pending before any Court or Tribunal relating thereto. Our liability under this present Guarantee being absolute and unequivocal. The payment so made by us under this Guarantee shall be a valid discharge of our liability for payment there under. Our liability to pay is not dependent or conditional on the Beneficiary proceeding against the MGT provider(s).
